MINUTES MOUNTAIN IRON CITY COUNCIL FEBRUARY 2, 2011

Mayor Skalko called the City Council meeting to order at 6:30 p.m. with the following members present: Joe Prebeg, Jr., Tony Zupancich, Susan Tuomela, Ed Roskoski, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; Jill M. Anderson, Municipal Services Secretary; Don Kleinschmidt, Director of Public Works; Rod Flannigan, City Engineer; and John Backman, Sergeant.

It was moved by Skalko and seconded by Prebeg that the consent agenda be approved as follows:

- 1. Add the following to the Agenda:
 - IV. A. Mayor's Report 4. Temporary Appointment-Personnel Committee
 - 5. Temporary Appointment-Planning & Zoning Liaison
 - 6. Resolution Number 01-11, Local Government Aid
- 2. Approve the minutes of the January 18, 2011, regular meeting with the following additions (noted in italics) to the recognitions:

Page 3, "He recognized Ray Saari, Co-Chair; Bernadette Suomi, Treasurer; Kathy Irish, Secretary; Ted Newberg, member; Vi Newberg, Executive Committee Member; William Buria, Executive Committee Member; and Dale Irish, Executive Committee Member. Also, a thank you to Rod Flannigan of Benchmark Engineering for assisting with the expertise and planning for the canopy project. Also, a thank you to Mary Somnis of the Iron Range Resource Culture and Tourism Board for the funding."

- 3. To acknowledge the receipts for the period January 15-31, 2011, totaling \$294,887.61, (a list is attached and made a part of these minutes).
- 4. To authorize the payments of the bills and payroll for the period January 16-31, 2011, totaling \$180,063.03, (a list is attached and made a part of these minutes).

The motion carried unanimously on a roll call vote.

The Mayor commented on the following items:

- Mesabi Daily News Editorial. He commented on the Mesabi Daily News Editorial regarding the Board and Commission appointments made at a recent City Council meeting. He said that Mr. Hanna, Editor at the Mesabi Daily News, did not complete any research to determine how the Mountain Iron City Council makes those appointments. He said that the Mayor makes nominations for appointments and the Council votes on those nominations for a formal appointment.
- Locomotive Park. He commented on the recent consideration of the Saint Louis County Community Development Block Grant Application for a grant for \$50,000 for Locomotive Park. He expressed displeasure with Councilor Roskoski addressing the

Saint Louis County Board and thanking them for not awarding the City the grant funds. He said that all the residents in Mountain Iron lose out when the City is not awarded grant funds. Councilor Roskoski responded with a historical overview of the grant funds that have been awarded to the City for Locomotive Park. Councilor Roskoski said that this Council has changed Locomotive Park from an historical site into a picnic area and he is not supportive to this change and does not support any grant funding being awarded to accomplish this. Councilor Prebeg also expressed his displeasure with Councilor Roskoski's comments made to the St. Louis County Board.

At 6:55 p.m., Councilor Roskoski left the meeting.

Councilor Zupancich also expressed displeasure with Councilor Roskoski's comments made to the St. Louis County Board. He said that Councilor Roskoski did not respect the majority decision of the Council and the Taxpayers of Mountain Iron. He thanked the St. Louis County Board for considering the City's grant application.

Councilor Tuomela asked Mayor Skalko why he brought the issue to a public meeting rather than speaking with Councilor Roskoski privately. The Mayor said that the people of Mountain Iron have a right to know what Councilor Roskoski is doing against the City.

At 7:01 p.m., Councilor Roskoski returned to the meeting.

It was moved by Zupancich and seconded by Tuomela to authorize a contribution of \$250 to the Virginia Regional Medical Center Diabetes Center for the Mark "Bush" Prebeg Memorial Snowmobile Ride with the funds being expended from the Charitable Gambling Fund. The motion carried unanimously on a roll call vote.

It was moved by Skalko and seconded by Zupancich to adopt the Proclamation for the Prebeg Memorial Snowmobile Ride on February 19, 2011, (a copy is attached and made a part of these minutes), and publish one time, in the February 18, 2011, edition of the Hometown Focus. It was moved by Roskoski to amend the motion and seconded by Prebeg to also publish the Proclamation in the Mesabi Daily News. The amendment for the motion carried with Mayor Skalko voting no. The amended motion carried unanimously.

It was moved by Roskoski and seconded by Tuomela to authorize the assistance of the Sheriff's Department for traffic control along Highway 169 on February 19, 2011, for the Prebeg Memorial Snowmobile Ride. The motion carried.

It was moved by Zupancich and seconded by Tuomela to authorize the assistance of the Public Works Department with some snow removal along Highway 169 on February 19, 2011, for the Prebeg Memorial Snowmobile Ride. The motion carried.

Councilor Prebeg personally thanked the Council for all of their assistance to the Prebeg Memorial Snowmobile Ride.

It was moved by Skalko and seconded by Prebeg to temporarily appoint Councilor Tuomela for the period February through April, 2011 and Mayor Skalko for the period May through July, 2011, to serve on the Personnel Committee in the absence of Councilor Zupancich. The motion carried.

It was moved by Skalko and seconded by Zupancich to temporarily appoint Councilor Prebeg to the Planning and Zoning Commission in the absence of Councilor Zupancich, for approximately a six month period. The motion carried.

It was moved by Zupancich and seconded by Prebeg to adopt Resolution Number 01-11, Supporting Local Government Aid, (a copy is attached and made a part of these minutes). The motion carried.

It was moved by Prebeg and seconded by Tuomela to authorize the Municipal Services Secretary to attend the Municipal Clerks and Finance Officers Association Annual Conference from March 15-18, 2011, at City expense. The motion carried unanimously on a roll call vote.

The City Administrator commented on the following:

- Maintenance Position. He said that there have been a large number of applicants and the Personnel Committee should have a recommendation for the Council to consider at the next regular meeting.
- > Hydrants. He thanked the residents for cleaning the snow from around the hydrants in the City.

The Council reviewed the December 2010 Sheriff's Department monthly statistics.

It was moved by Prebeg and seconded by Zupancich to authorize the purchase of a 2011 Ford Crown Victoria from Lundgren Motors at the state bid quoted price of \$22,057.64. The motion carried unanimously on a roll call vote.

Sergeant Backman wanted to recognize Deputy Shackman for his efforts in arresting a person that was involved in a theft in Mountain Iron. He said that the person that was arrested had committed 20 felonies in a one month period. Deputy Shackman's initiative in this matter was what brought this person to justice and he wanted him to be recognized.

Sergeant Backman informed the public that the Saint Louis County Sheriff's Department was accepting applications for qualified Deputy Sheriffs.

Sergeant Backman also advised the public that there are new waves of scams going around with phone calls requesting money for sweepstakes. He said that if something sounds too good to be true, it probably is.

It was moved by Roskoski that in regard to the water pressure situation at the Energy Park, that the City Council be reported to, in writing, what that problem is and at the same time, various options be explored by Benchmark Engineering along with associated costs on what can be done to rectify that low water pressure situation; with a deadline of March 1, 2011, so potential grant applications could be submitted. The Mayor would not allow the motion, as it was out of order and not placed on the agenda. The City Engineer informed the Council that Benchmark Engineering had completed a water analysis and that analysis should be submitted by March 1, 2011 to the City Council.

It was moved by Zupancich and seconded by Prebeg to allow City Staff to work with the Public Health and Safety Board to complete the research necessary and to look for an organization and consultants to develop a long range plan for the City. The motion carried with Roskoski voting no.

It was moved by Roskoski and seconded by Skalko to authorize Benchmark Engineering to prepare a Drainage and Improvement Plan for the Westgate/West Virginia and other areas deemed necessary, and if there is work that needs to be completed, to propose the completion of the work in three or four phases, at a cost not to exceed \$15,000. The motion carried unanimously on a roll call vote.

During the Liaison Reports, Councilor Roskoski questioned the proposed rental ordinance being reviewed by the Planning and Zoning Commission. He requested that affected property owners should be contacted for their input. Councilor Zupancich said that the Planning and Zoning Commission have not yet completed the review of the Ordinance. He said that once the review is completed, that other affected Boards and Commissions will also be able to review the Ordinance.

It was moved by Zupancich and seconded by Tuomela to adopt Ordinance Number 01-11, Amending Chapter 70 of the Mountain Iron City Code, (a copy is attached and made a part of these minutes).

At 7:46 p.m., Mayor Skalko left the meeting.

At 7:47 p.m., Mayor Skalko returned to the meeting.

The motion carried with Roskoski voting no.

It was moved by Zupancich and seconded by Tuomela to adopt Ordinance Number 02-11, an ordinance authorizing the City of Mountain Iron to grant permission to holders of On-sale Wine and On-sale 3.2 Percent Malt Liquor Licenses whose gross receipts are at least 60% attributable to the sale of food to sell intoxicating malt liquor (strong beer) at on-sale without obtaining an additional license, (a copy is attached and made a part of these minutes). The motion carried unanimously.

It was moved by Prebeg and seconded by Tuomela to accept the recommendation of the Librarian to authorize the continuation of employment for Kelly Belleville, Assistant Librarian, beyond her probation period. The motion carried unanimously.

It was moved by Prebeg and seconded by Tuomela to set a special closed meeting under Minnesota Statute Section 13D.05, Subdivision 2B for the preliminary consideration of allegations or charges against an individual subject to the public body's authority for Tuesday, February 22, 2011, at 5:00 p.m. The motion carried unanimously.

At 7:55 p.m., it was moved by Skalko and seconded by Zupancich that the meeting be adjourned. The motion carried.

RESOLUTION NUMBER 01-11

SUPPORTING LOCAL GOVERNMENT AID

WHEREAS, LGA is a state funded property tax relief program that helps reduce the property tax burden on homeowners and businesses in Mountain Iron; and,

WHEREAS, without LGA property taxes would have to be increased by 100% or services would have to be cut even more in Mountain Iron; and,

WHEREAS, LGA to Mountain Iron has already been cut \$342,640 since; and,

WHEREAS, the city will have to increase taxes on its residents and businesses and lower services if LGA is cut or eliminated; and,

WHEREAS, higher property taxes and lower services in Mountain Iron will make it even less competitive for jobs and economic growth with suburban cities in Minnesota and in cities in other states; and,

WHEREAS, the state has certified that Mountain Iron will receive \$1,354,430 in LGA for 2011; and

WHEREAS, the city has set its budget and will be several months into its budget year before the Legislature acts on the state budget; and,

WHEREAS, LGA has already been cut over \$1 billion and city property taxes are up 59% since 2003.

NOW, THEREFORE, BE IT RESOLVED BY THE MOUNTAIN IRON CITY COUNCIL, that the City of Mountain Iron urges the Legislature to keep its promise and pay the city the \$1,354,430 of LGA it already certified to the city for 2011.

BE IT FURTHER RESOLVED, that the Legislature maintain funding for LGA at its current funding level for 2011 and 2012.

BE IT FURTHER RESOLVED, that upon passage, this resolution be forwarded to the Governor, the Speaker of the House, the Senate Majority Leader, and to the members of the State Legislature representing the city of Mountain Iron.

ORDINANCE NUMBER 01-11

AMENDING CHAPTER 70 OF THE MOUNTAIN IRON CITY CODE

THE CITY OF MOUNTAIN IRON HEREBY ORDAINS:

<u>Section 1.</u> Amending Section 70.11. Section 70.11 of the Mountain Iron City Code is hereby repealed and replaced with the following:

70.11 Unlawful Overtime Parking. It shall be unlawful to park a car, pick-up truck, van or motorcycle on any City street, alley or public parking lot for longer than:

Subd. 1. 24 consecutive hours from during calendar parking.

Subd. 2. 72 consecutive hours from during the remainder of the year.

<u>Section 2.</u> Adding Section 70.13.

City Code and shall read as follows:

Section 70.13 is hereby added to the Mountain Iron

70.13 CALENDAR PARKING.

- Subd .1. The calendar system of parking is adopted which means that all parking from 12:00 p.m. to 12:00 p.m. on even days of the month shall be allowed only on the even side of the street or avenue and on the odd days of the month on the odd side of the street or avenue commencing November 1st and continuing until April 1st of each year. The allowed changeover period during each day shall be from 6:00 p.m. to 11:00 p.m.
- Subd. 2. During calendar parking any Law Enforcement officer may remove a vehicle from a street to a garage or other place of safety when the vehicle is left unattended and constitutes an obstruction to traffic or hinders snow removal or street improvement or maintenance operations. Such vehicle shall not be released until the fees for towing and storage are paid in addition to any fine imposed for a violation of this schedule. Violation of this schedule shall result in fines to be established by Council Resolution from time to time.

Section 3. Adding Section 70.14.
City Code and shall read as follows:

Section 70.14 is hereby added to the Mountain Iron

70.14 Parking Restrictions on Marble Avenue and Main Street.

- Subd. 1. There shall be no parking on east side of Marble Street from Coral Street to Main Street except when the Mountain Iron-Buhl High School has scheduled events.
- Subd. 2. There shall be no parking between 2:00 a.m. and 6:00 a.m. on the west side of Marble Avenue from Coral Street to Main Street between November 1st and April 1st of each year.
- Subd. 3. Parking Permits. The west side of Marble Avenue between Main Street and Coral Street shall be posted and reserved for the parking of residents. To facilitate enforcement of the parking regulations, the City shall issue numbered parking permits to the residents along Marble Avenue between Main Street and Coral Street. Residents to whom such permits are issued are responsible for displaying the permits on the vehicle for which they are issued on the windshield or visor where they can be clearly seen. Loss or theft of the permit shall be reported to the Sheriff or City Administrator.
- Subd. 4. There shall be no parking between 2:00 a.m. and 6:00 a.m. on Main Street from Mineral Avenue to Mesabi Avenue between November 1st and April 1st of each year.

Section 4. Repealing Chapters 74 and 75. The following Chapters are hereby repealed and shall be removed in their entirety from the Mountain Iron City Code:

Subd. 1.

Chapter 74 - Traffic Schedules

Subd. 2.

Chapter 75 - Parking Schedules

Section 5. Inconsistent Ordinances. All Ordinances or portions thereof inconsistent with this Ordinance shall be repealed and replaced with the provisions of this Ordinance.

Section 6. Effective Date. Statute.

This Ordinance shall be effective in accordance with State

AN ORDINANCE AUTHORIZING THE CITY OF MOUNTAIN IRON TO GRANT PERMISSION TO HOLDERS OF ON-SALE WINE AND ON-SALE 3.2 PERCENT MALT LIQUOR LICENSES WHOSE GROSS RECEIPTS ARE AT LEAST 60% ATTRIBUTABLE TO THE SALE OF FOOD TO SELL INTOXICATING MALT LIQUOR (STRONG BEER) AT ON-SALE WITHOUT OBTAINING AN ADDITIONAL LICENSE.

THE CITY COUNCIL OF THE CITY OF MOUNTAIN IRON DOES ORDAIN:

- Section 1. City Authorized to Grant Holders of On-Sale Wine and 3.2 On-Sale Beer Licenses to Sell Strong Beer at On-Sale. Pursuant to Minnesota Statutes 340A.404, the Mountain Iron City Council is hereby authorized to permit holders of both on-sale wine and on-sale 3.2 percent malt liquor licenses, whose gross receipts are at least 60% attributable to the sale of food, to sell intoxicating malt liquor (strong beer) at on-sale without obtaining an additional license, with no additional fee to be charged.
- Section 2. Definition of Intoxicating Malt Liquor (Strong Beer). Intoxicating malt liquor (strong beer) is any beer, ale, or other beverage made from malt by fermentation and containing more than one-half of one percent alcohol by volume or more than 3.2 percent alcohol by weight.
- <u>Section 3. Sunday Sales Permitted.</u> Sale of on-sale wine and on-sale strong beer are permitted on Sundays, pursuant to State Law.
- Section 4. Insurance Requirement. Holders of both on-sale wine and on-sale 3.2 percent malt liquor licenses, who have been granted permission to sell intoxicating malt liquor (strong beer) shall carry liability insurance as is required pursuant to Minnesota Statutes 340A, and the City of Mountain Iron City Code Chapter 114.
- Section 5. Penalties. Persons who are holders of both on-sale wine and on-sale 3.2 percent malt liquor licenses, who have been granted permission to sell intoxicating malt liquor (strong beer), who violate provisions of Minnesota Statutes 340A, and the City of City of Mountain Iron City Code Chapter 114, as may be amended from time to time, is guilty of a misdemeanor and upon conviction shall be punished as provided by law.

Section 6. Repeal of Inconsistent Ordinance. All Ordinances inconsistent herewith are hereby repealed and replaced with the provisions of this Ordinance.

Section 7. Effective Date. This Ordinance shall be effective according to State Statute.

This project consists of the construction of a 10 foot wide paved trail following the planned Unity Drive corridor heading east from the South Grove neighborhood. This trail would connect to the sidewalk system which ends at the intersection with Diamond Lane. The proposed trail system will connect the City's neighborhoods together. The South Grove neighborhood is home to many Mountain Iron Residents and does not have pedestrian or bicycle connections to the community center, schools, or other important destinations. Currently no connection exists in this area. Once completed, the project will be immediately available to the public.

36. Costs Associated with the Project:

\$75,000 in earthwork, \$50,000 in paving, \$50,000 for select fill and \$25,000 Engineering. Matching funds will be budgeted by the City in 2012. The five year maintenance will be of minimal cost and be in conjunction with the maintenance the City performs on other trails within its jurisdiction.

42. Public Need for and Benefit of Project:

The City of Mountain Iron is spread out between several neighborhood nodes and separated by Highway 169 and other roads. South Grove is home to many residents, and recreation facilities and is approximately ½ mile from important community destinations such as the elementary school, community center, clinic, recreation facilities, residential neighborhoods, and businesses.

The trail will connect to the elementary school, community center, and other neighborhoods. The City will seek to complete this phase of the local trails plan using other funding sources.

The recently completed Safe Routes to School plan found that lacking non-motorized transportation facilities were among the major reasons that parents did not let their children walk or bike to school. Connecting the elementary school is likely to increase the number of students walking and biking to school since parents are more likely to let older students partake in these activities.

43. Community Commitment to Trail Use:

Enclosed, please find the City of Mountain Iron's Bicycle and Pedestrian Plan which has been implemented and outline the actions we are taking.

44. Impact on Adjoining Landowners in the Vicinity of the Project:

The project will have minimum impacts on adjacent property owners, since the project is non-motorized it is similar to having a sidewalk in front of your property

45. Attention to the Potential Environmental Impact of the Project and Efforts to Avoid or Mitigate Adverse Effects:

Environmental impacts are expected to be limited. About 1/2 acre of impervious surface will be added. However, this will be spread out over 1/2 mile. The trail will be constructed within public right of way that is already cleared and partially graded.

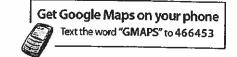

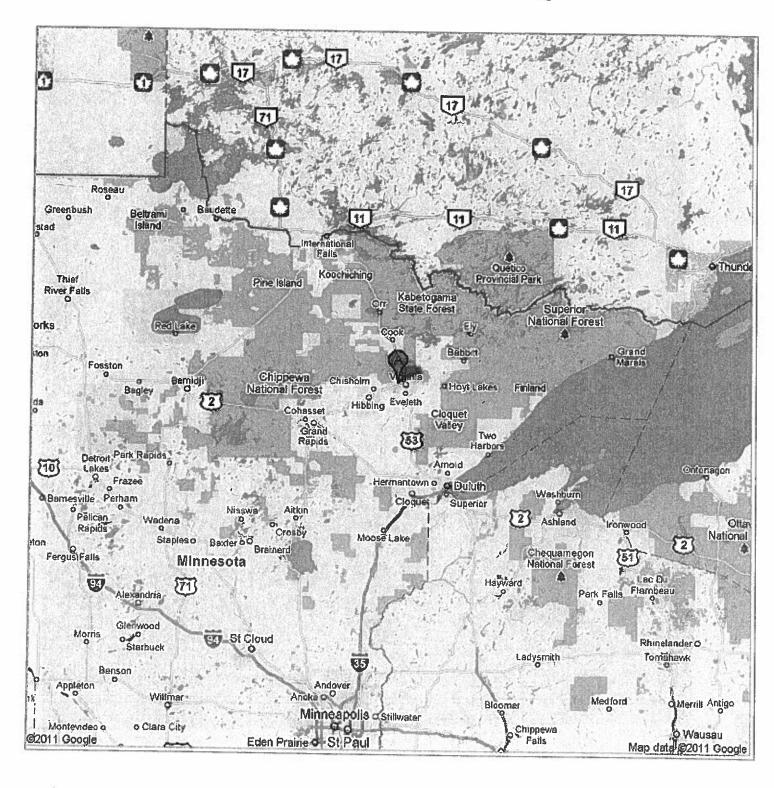

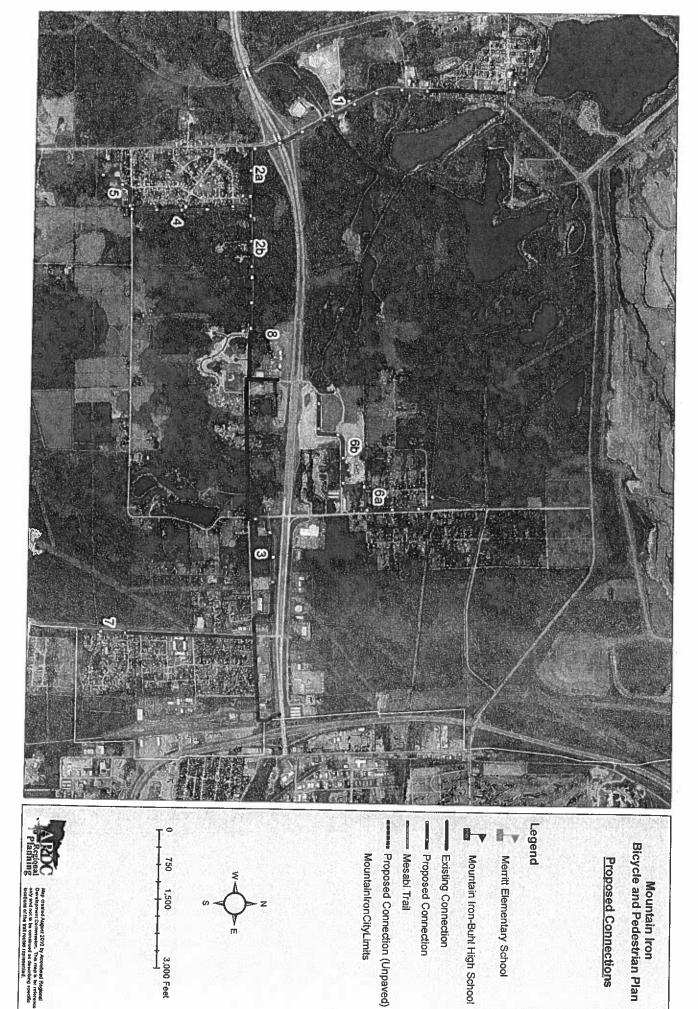

Realignment of Highway 53 — Virginia to Eveleth



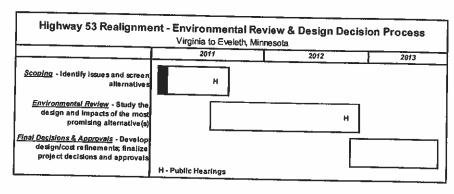
Project Information – Minnesota Department of Transportation (Mn/DOT) SP 6918-80 January 2011

Why is the Highway 53 realignment being planned?

On May 5, 2010, Cliffs Natural Resources provided notice to Mn/DOT that US Highway 53 easement rights across the United Taconite Mine, per a 1960 agreement, would be terminated. United Taconite agreed to allow seven years for the relocation of Highway 53. Therefore, by May 2017, Mn/DOT must vacate the segment of US 53 from about 12th Avenue West to Vermillion Drive in Virginia, Minnesota. Planning for a new Highway 53 alignment, including design changes to the Highway 135 junction and route, will require evaluations of several alternatives and their potential impacts. Some major goals for the project include cost-effectiveness, timely and sound decision-making, maintaining safe and efficient highway connections, avoiding or minimizing negative impacts, and avoiding unacceptable highway-mine conflicts far into the future.

What is the project planning process? – How long will it take?

The project planning process and current status are illustrated here. Current project work is in the "Scoping" phase, where many alternatives will be identified and considered. During Scoping, the Mn/DOT project team will share information and encourage input from local community leaders, many agencies, United Taconite, and the



general public. Based on this immediate Scoping process, the number of alternatives will be reduced.

Later this year, the Scoping process will conclude with a public hearing and decisions about which alternative(s) should remain as the most promising for project design studies, detailed impact evaluations, and final project development. The detailed environmental review is planned to take about one year, followed by final project decision-making, approvals, and design refinements. The final project decisions are scheduled for 2013; however, Mn/DOT will seek reasonable opportunities to accelerate the schedule. A final project design and construction process will occur after the above-outlined study process, with the goal to open a new Highway 53 alignment before May 2017.

What alternatives, issues, and criteria will be considered?

While the detailed study of alternatives is just getting started, several alternatives and issues have been identified. For more information, please see the map: Highway 53 Realignment Alternatives. The alternatives and issues initially being considered are based on realignments proposed in work previously completed by Mn/DOT and United Taconite. These alternatives include:

- West Corridor Alternatives (W-1, W-2, and W-3)—The West corridors are the only alternatives with the potential to
 avoid all or most of the iron mining conflicts anticipated with the other alternatives. However, the West alternatives
 involve construction or reconstruction of at least 10 miles of highway. Some of the issues for these alternatives will
 include:
 - Questions of whether the re-routing of Highway 53, and Highway 135, would provide transportation benefits or create inefficiencies, especially in regard to community access
 - The importance of avoiding the mine versus the greater scale of West corridor alternatives—including the costs and impacts of West alternatives to private properties, businesses, wetlands, streams, and existing highway/railroad infrastructure
- Middle or Mine-Area Corridor Alternatives (M-1 and M-2)—The Middle corridors cross over the United Taconite
 iron ore pit approximately ½-mile west of existing Highway 53 and are the most direct new routings for the highway.



These alternatives involve construction or reconstruction of up to 2 miles of highway. Issues for these alternatives will include:

- As-yet uncertain impacts and environmental permit requirements (most notably air quality) due to relocation
 of the highway through the mine
- Potential conflicts with United Taconite mining operations, including highway design across the mine to allow mining trucks and equipment to cross under/over a new highway and the risk that the highway would need to be relocated again in the future
- Highway design needed to maintain good access to Highway 135 and to downtown Virginia, similar to the existing 2nd Avenue access
- East Corridor Alternatives (E-1, E-2, and E-3)—All East corridors involve routing Highway 53 around and through
 portions of the "Rouchleau Pit," a previously mined area that would require construction of a new bridge crossing. A
 key decision point with the East alternatives is whether to reconnect to existing Highway 53 at approximately 2nd
 Avenue, or to realign around the north side of Virginia. The East alternatives would require construction or
 reconstruction of 3-5 miles of highway and the issues would include:
 - The presence of known iron ore reserves in these corridors, which raises the possibility of Highway 53 relocation again in the future
 - The history of underground mines in this area, which creates subsidence risks and could complicate cost estimating, construction, and long-term maintenance
 - The feasibility of reconstructing Highway 53 through or near city of Virginia neighborhoods and business districts

Some of the initial criteria to be considered for all project alternatives will include:

- Highway safety and efficiency, including connections between communities using Highway 53, Highway 135, and other routes
- Cost effectiveness and risks for long-term cost
- Various environmental/community impacts—Air quality, water quality, wetlands, historic sites, effects on the local/regional economy, and compatibility of alternatives with community plans and economic development

Mn/DOT is committed to balancing these and other criteria to reach timely implementation. The state's commitment is also supported by \$60 million in trunk highway bonds.

How will community input be provided?

Mn/DOT looks forward to receiving input from those affected by the project and will soon begin a series of committee and public meetings.
