MINUTES SPECIAL MEETING MOUNTAIN IRON CITY COUNCIL FEBRUARY 18, 2014

Mayor Skalko called the City Council meeting to order at 5:00 p.m. with the following members present: Joseph Prebeg, Jr., Susan Tuomela, Tony Zupancich, Alan Stanaway, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; Jill M. Clark, Municipal Services Secretary; Rod Flannigan, City Engineer; and Brian Lindsay, City Attorney.

The special meeting was for a public hearing for special assessments on Mountain Iron Drive, Rock Ridge Drive, Fairview Lane, and South Court.

The Mayor announced that, after speaking to the City Engineer, the Council would postpone the South Court Project until 2015, so that all options could be reviewed.

The Mayor said the public input would be taken by project.

SOUTH COURT:

Jeanie Fiorini, 5386 South Court, read a written objection, signed by all the affected property owners on South Court, objecting to the proposed assessments and the City's Local Improvement Policy.

Perry Fiorini, 5386 South Court, submitted the written objection to the Council, protesting the 90% assessment.

Ed Roskoski, 5409 North Court, interjected some history to the construction of South Court.

FAIRVIEW LANE:

Mary Erickson, 5404 Park Drive, said that she lives on the corner of Park Drive and Fairview Lane and that she had some water problems with water coming onto her property. She was concerned with the overlay not addressing her water issues and if the complete reconstruct would better address her water situation.

Thomas Bratulich, 8745 Fairview Lane, does not want the City Council spending their money. He said that he was opposed to the project. He felt that there was nothing wrong with the street.

Jerry Stefanich, 8754 Fairview Lane, asked how the residents know what the final construction costs would be. The Engineer said that the final assessment roll is based on the actual construction costs.

Connie Rabideaux, 8741 Fairview Lane, said that they were assessed in 1987 and then in 1993 the natural gas lines were installed and they damaged the road and it was never repaired appropriately. She said she did not want to have the road improved and have the same thing happen. She supported option #1.

Dan Miettunen, 8739 Fairview Lane, questioned what was going to done for option #1. The Engineer said that they would be milling and replacing the bituminous. Mr. Miettunen said that the majority of the curbs were adequate, but there are a few that are bad. He said that he was in favor of completing option #1 with some of the curbs being repaired.

Bernadette Suomi, 8754 Greenwood Lane, for option #1. She wants the special discount for corner lot owners. She is in favor of option #1.

Harriet Scinto, 8781 Fairview Lane, addressed the drainage problem at 5404 Park Drive, she said it was caused by the fire break that was made back in 1977, and it destroyed the natural drainage. The City Engineer said fixing the drainage would be more of a maintenance issue.

Glen Avikainen, 8750 Fairview Lane, said that he had no curb in front of his house. He was in favor of option #1.

Larry Tokarczyk, 8787 Fairview Lane, said that the drainage pipe on their lot gets plugged up and water flows west of them and backs up in their driveway. He also suggested that the Council put the correct language in the Local Improvement Policy.

Margaret Soyring, 8756 Fairview Lane, said that she was in favor of option #1 and she approved of the curbing being fixed. She said she was also speaking for Dave Laughton, 8751 Fairview Lane, because he had to work and he also was against option #2 and is in favor of option #1.

Robert and Connie Fingeroos, 8742 Fairview Lane, said that they were in favor of option #1.

Janette Koski, 8747 Fairview Lane, said that she was in favor of option #1.

MOUNTAIN IRON DRIVE:

Jim Makowsky, General Manager of the AmericInn, 5480 Mountain Iron Drive, requested that the for future mailings that the City specify to what extent the different options were.

The Engineer said the following:

Option #1 - mill and overlay the entire road

Option #2 – reconstruct the South half

Option #3 - mill and overlay the north half and complete reconstruct the south half

Option #4 – total reconstruct of entire road

Mr. Makowsky felt that an overlay of the entire road, option #1, would be a waste of money. He felt that the total reconstruct was the most costly, but would benefit the land owners the most.

He also brought up and discussed the City establishing a quiet zone for the train whistles in Mountain Iron.

WHEREAS, in Minnesota, 357,000 low-wage workers deserve a raise; they help us raise our children, care for our aging parents, clean our offices, serve our food and more; they help everybody else do their jobs, yet they do not share the prosperity they help create; their professions have been undervalued for far too long and it's time to make their hard work pay; and

WHEREAS, full-time wages for someone earning \$7.25 an hour come to only \$15,080 a year and that is not enough to meet basic needs; and

WHEREAS, in a Minnesota family with two full-time working adults and two children, each parent needs to earn \$14.03 an hour just to meet basic needs; and

WHEREAS, based on data contained in the 2012 American Community Survey, raising the minimum wage to \$9.50 an hour would pump more than \$470 million in consumer spending power to fuel Minnesota's economy; and

WHEREAS, although raising the minimum wage to \$9.50 an hour remains popular, with support consistently polling above 70%, this strong public support has not translated into action by the Minnesota legislature.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MOUNTAIN IRON, MINNESOTA, that the Mountain Iron City Council hereby expresses its support for the campaign to ask the Minnesota legislature to raise the minimum wage to at least \$9.50 an hour by 2015 and index it to inflation.

BE IT FURTHER RESOLVED, that the City Council additionally urges area legislators to commit their support to this initiative.
