MINUTES MOUNTAIN IRON CITY COUNCIL FEBRUARY 19, 2013

Mayor Skalko called the City Council meeting to order at 6:31 p.m. with the following members present: Joe Prebeg, Jr., Susan Tuomela, Tony Zupancich, Alan Stanaway, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; Jill M. Clark, Municipal Services Secretary; Michael Downs, Interim Director of Public Works; Rod Flannigan, City Engineer; John Backman, Sergeant; and Brian Lindsay, City Attorney.

It was moved by Skalko and seconded by Tuomela that the consent agenda be approved as follows:

- 1. Approve the minutes of the February 4, 2013, regular meeting as submitted.
- 2. That the communications be accepted and placed on file and those requiring further action by the City Council be acted upon during their proper sequence on the agenda.
- 3. To acknowledge the receipts for the period February 1-15, 2013 totaling \$166,954.21, (a list is attached and made a part of these minutes).
- 4. To authorize the payments of the bills and payroll for the period February 1-15, 2013, totaling \$505,584.77, (a list is attached and made a part of these minutes).

The motion carried unanimously on a roll call vote.

No one spoke during the public forum.

The Mayor reported on the following:

Mesabi Daily News. He pointed out that there was an article in the February 17, 2013, Mesabi Daily News by Bill Hanna regarding the bidding process for the City's legal publication. Councilor Tuomela addressed the article; she said that the City had never solicited bids. She said that Mr. Hanna was present at the January 7, 2013, Council meeting and never spoke during the public forum regarding the City's legal publication. She further outlined her view on the Mesabi Daily News and the Hometown Focus. She also addressed the onion in the February 9, 2013, Mesabi Daily News regarding the "puppet type Council", and she said that she was not a puppet for anyone. Councilor Zupancich also addressed the issue stating that he has some of the same sentiments that Councilor Tuomela had. Councilor Zupancich stated that he supports the Hometown Focus because it truly is a locally owned newspaper and that anyone can get a copy of the newspaper at no cost to them. Mayor Skalko also addressed the article regarding the legal publication, he said that no bids were solicited for the City's legal publication. legal services, or engineering services. The Mayor felt that the "unsigned" onions in the Mesabi Daily News have no merit and the writers are not accountable. The Mayor said that he welcomes criticism, but wants to know the source of the criticism to address the issue.

- Acknowledgements. He acknowledged the passing of Calvin Johnson. Condolences were expressed to the family.
- Eldest Residents. He said that he was seeking input on the eldest residents in Mountain Iron. He received information on the following residents: Illa Brunfelt, 101; Ione Marincel, 98; Katherine Holmes, 98; Gladys Johnson, 93; Bill Riccio, 93; and Paul Fisher, 93. He requested that residents inform him if there is someone that should also be recognized.
- Fire Hydrants. He requested that the residents keep the hydrants located by their homes cleared of snow to be available, in case of emergency, by the Fire Department.

The City Administrator reported on the following:

- > Special Event. He reminded the residents of the Mish Mash Mush Winter Carnival event scheduled for Saturday, March 2, 2013, from 1:00-5:00 p.m. at the South Grove Recreation Facility.
- Public Access Television. He said that Terry Hartikka, Director of the Public Access Television, is now being run by Mesabi Community Television, a sole proprietorship, housed in the Virginia City Hall. He said that viewing of the City Council meetings and other area events can be found at www.mesabicommunitytv.com

It was moved by Zupancich and seconded by Tuomela to accept the recommendation of the Planning and Zoning Commission and approve the final plat for the Energy Park of Mountain Iron. The motion carried.

It was moved by Prebeg and seconded by Stanaway to accept the recommendation of the Personnel Committee and authorize an hourly rate increase for training and fire calls for the Mountain Iron Fire Department from \$10 to \$12 per hour. The motion carried unanimously on a roll call vote.

During the liaison reports, Councilor Stanaway reported that the Fire Department took delivery of the 1994 fire truck and the department was currently fitting the truck with the equipment removed from the 1988 fire truck and the department members were getting acquainted with the truck. He said that the truck is very impressive and should serve the City well.

It was moved by Zupancich and seconded by Tuomela to adopt Resolution Number 05-13, receiving report and calling for a hearing on March 18, 2013, at 5:00 p.m. for the extension of Unity Drive (a copy is attached and made a part of these minutes). The motion carried.

It was moved by Prebeg and seconded by Tuomela to adopt Resolution Number 06-13, ordering preparation of report on improvement for Silicon Way, (a copy is attached and made a part of these minutes). The motion carried.

It was moved by Stanaway and seconded by Tuomela to authorize City Staff to seek bids for the sale of the 1988 fire truck. The motion carried.

BACKGROUND

On February 19, 2013 the Mountain Iron City Council requested a feasibility report to make improvements to Silicon Drive. The City Council requested Benchmark Engineering evaluate whether the proposed improvement is necessary, cost effective and feasible.

EXISTING CONDITIONS

Silicon Drive was originally constructed in 2010 to provide access to Silicon Energy, a solar panel manufacturing company operating in the Mountain Iron Renewable Energy Park. Silicon Drive was originally constructed with adequate gravel thicknesses to accommodate bituminous paving in the future. Silicon Drive was constructed on a section of 10" of aggregate base class 5, 12" select granular material, and a Type V geotextile material. This road section was designed to handle heavy traffic loading as the Mountain Iron Renewable Energy Park develops. The area of the city is zoned for manufacturing and industrial type usage.

In 2013, County Road 102 will be realigned to pass just past along the north side of the Mountain Iron Renewable Energy Park. As part of this construction project, a portion Silicon Drive reconstructed and realigned to match the new County Road 102. Silicon Drive will be reconstructed with the same road section as existing, but realigned to match the new County Road 102 in accordance with Saint Louis County roadway design standards. Please refer to the enclosed project location map for the new alignment of County Road 102 and Silicon Drive for this feasibility study.

The existing gravel roadway surface of Silicon Drive can create dust control problems for the Silicon Energy facility. In addition, the existing gravel surface requires additional maintenance by the City Street Department.

PROPOSED IMPROVEMENT PLAN

Silicon Drive is approximately 900 feet in length from the intersection with new County Road 102 to its current southerly terminus just past the Silicon Energy facility driveway.

A total of two bituminous paving options are evaluated for Silicon Drive. The proposed improvement options are as follows:

Option 1 – Bituminous Paving with Curb & Gutter (Urban Section)

A bituminous street would be designed and constructed to match the in place profile of Silicon Drive located within the City of Mountain Iron.

The Road would be paved 28 feet wide with curb and gutter constructed on both sides. Storm sewers are currently in place on the south half of this roadway and would be used to direct storm water to an existing stormwater sedimentation pond. Additional storm sewer structures and pipe would have to

be constructed for this proposed improvement to adequately convey runoff to the stormwater pond. The existing class 5 surface would be graded and shimmed to create a smooth crowned surface prior to paving operations. Three lifts of bituminous paving, consisting of 3.5" of non-wearing bituminous and 1.5" of wearing bituminous surfacing would be constructed after curb & gutter is installed.

The placement of a five foot wide sidewalk on one side of Silicon Drive will also be included as an option for cost estimating purposes.

Advantages of this proposed improvement option:

- Matches the current typical design section of City of Mountain Iron local roadways.
- Provides a roadway storm sewer system, which may enhance future development of vacant lots.
- Sidewalk option would provide a safe path for pedestrian users within this road corridor.
- Silicon Energy has indicated that a paved street be constructed to minimize dust present in the facility during the manufacturing process.
- Increases value of Renewable Energy Park lots adjacent to Silicon Drive.

Disadvantages of this proposed improvement option:

- This option is the most expensive option.
- Sidewalks would see minimal use as they would not be connected to another part of the City's sidewalk system.
- Curb & gutter road section ties into a County Roadway with a rural (ditching) section.

Option 2: Bituminous Paving with ditches (Rural Section)

A bituminous street would be designed and constructed to match the in place profile of Silicon Drive located within the City of Mountain Iron.

The roadway would be paved 28 feet wide, with 4' gravel shoulders on each side of Silicon Drive. Storm sewers are present near the south half of this roadway and would be used to direct storm water to an existing stormwater sedimentation pond.

Again, the existing class 5 surface would be graded and shimmed to create a smooth crowned surface prior to paving operations. Three lifts of bituminous paving, consisting of 3.5" of non-wearing bituminous and 1.5" of wearing bituminous surfacing would be constructed with gravel shoulders.

Beyond the shoulders, ditches on each side of the roadway will convey drainage northerly to the roadside ditches along new County Road 102.

Advantages of this proposed improvement option:

- Closely matches the typical section of new County Road 102.
- Reduces future roadway maintenance.

- Silicon Energy has indicated that a paved street be constructed to minimize dust present in the facility during the manufacturing process.
- Increases value of Renewable Energy Park lots adjacent to Silicon Drive.
- Rural road section is more typical of industrial/commercial areas within the City of Mountain Iron (i.e. North Enterprise Drive and Merritt Industrial Park)
- Least cost option

Disadvantages of this proposed improvement option:

- No pedestrian access
- Roadside ditches will be adjacent to the road, which can increase future maintenance requirements.

OPINION OF COST SUMMARY

The following table summarizes the engineer's opinion of cost for each of the improvements included in this report. A complete cost estimate breakdown for this improvement plan is included within Appendix B of this report.

SOURCES OF FUNDING

It is our understanding that City Staff has obtained grant funding for this proposed improvement. Should additional funds be needed to complete this project, they would likely come out of the City's General Fund.

The City of Mountain Iron intends to assess property owners adjacent to this project area for a portion of the improvement costs. The City of Mountain Iron would be responsible for the remaining portion of the balance to complete any of these improvement options.

SUMMARY

In conclusion, the afore-mentioned information attempts to summarize the existing conditions and proposed improvement options for Silicon Drive within the City of Mountain Iron.

It would be recommended to complete these roadway improvements in conjunction with the realignment of County Road 102, as being completed by USS – Minntac.

It is our recommendation based on the preceding information and summary of improvement options, that option 2 would be the most feasible and cost effective choice in providing the City of Mountain Iron with the best long term improvement.



Advocates for Family Peace (AFFP) has been serving families experiencing domestic violence for over 30 years in Itasca County, MN. AFFP is a six-program agency that serves victims of domestic violence and their children through advocacy, housing, batterers intervention program for men and fathers, groups for women who have been arrested, supervised visitation and exchange, and parent education. AFFP has been recognized nationally and internationally for its curriculum *Addressing Fatherhood with Men Who Batter* and for its leadership of the Itasca County coordinated community response (CCR) to end domestic violence in partnership with criminal justice and community-based agencies.

The AFFP board of director's has recently changed its bylaws to extend its services to families experiencing domestic violence in northern St. Louis County. AFFP is taking over the service area previously served by Range Women's Advocates (RWA). AFFP will be providing advocacy for victims of domestic violence and their children, a 24 hour per day/7 day per week crisis line, criminal justice coordination with area prosecutors and law enforcement agencies, as well as groups for men and women who use violence. Men and women who have committed illegal acts of domestic violence and court ordered to a group process will now enroll in the Intervention Program for Men and Fathers (IPMF) and the Intervention Program for Women (IPW). The Range Intervention Project (R.I.P.), a program of RWA, is no longer be providing these groups as of January 2013.

The office serving northern St. Louis county will now be located at 2125 East 2nd Avenue Suite 44 in Hibbing, MN (located behind the Hibbing Daily Tribune). Staff will travel to all parts of northern St. Louis county to assist victims of domestic violence and their children. The phone number of the office is 218-263-8344 or 1-800-909-8336. Victims of domestic violence and local law enforcement agencies can also call these numbers for assistance after office hours to reach an on-call advocate.

The City Council may go into Closed Session to discuss the negotiation being under taken with management personnel. The meeting is being closed pursuant to 2012 Minnesota Statutes 13D.03

The following provisions of State Statute must be observed:

- Before closing the meeting, the council must decide to close the meeting by a majority vote at a public meeting and must announce the time and place of the closed meeting.
- Before closing the meeting, the council must state on the record the specific grounds permitting the meeting to be closed and describe the subject to be discussed.
- A written record of all people present at the closed meeting must be available to the public after the closed meeting.
- The meeting must be tape-recorded.
- The recording must be kept for two years after the contract is signed.
- The recording becomes public after all labor agreements are signed by the city council for the current budget period.
