MINUTES
MOUNTAIN IRON CITY COUNCIL
COMMITTEE OF THE WHOLE MEETING
MARCH 12, 2012

The meeting was called to order at 6:34 p.m. with the following members present: Joe Prebeg, Jr., Susan Tuomela, Ed Roskoski, and Mayor Gary Skalko. Planning and Zoning members present: Barb Fivecoate, Vicky Juntunen, Steve Skogman, Ray Saari, Jim Teacher and Margaret Soyring. Public Health and Safety Board members: Alan Stanaway. Also present were: Craig J. Wainio, City Administrator; Jerry Kujala, Zoning Administrator; Bob Brown, Building Inspector; Jerry Knapper, Fire Captain; Jeremy Waldron, Fire Captain and John Backman, Sheriff's Deputy.

Mr. Skogman opened the meeting by stating that no public input will be taken at this meeting and the purpose of the meeting is to get comments from the Board and Council. The floor was opened for questions for the Council. Councilor Roskoski expressed his concerns over the proposed ordinance. Councilor Prebeg stated that the ordinance has not been adopted and this meeting is to review the ordinance. Mayor Skalko expressed concerns over the costs of enforcement of the ordinance; he saw the ordinance as unenforceable. Skogman wanted to know if the ordinance was acceptable and if so the next step was to work on enforcement.

Tuomela stated that she reviewed area communities and not one outside of Ely has a rental ordinance. Mayor Skalko stated that basic safety standards and a reporting mechanism should be established.

Fivecoate questions what a tenant is to do if a house meets State safety standards but has other problems. Skalko stated that the minimum safety standards should be met but the property does not need to be "pretty".

Skogman asked if the Council would like them to move forward with the ordinance. Skalko wanted to move forward with some basic standards and mechanism for tenants to be heard. Saari was concerned about the costs of any enforcement of new regulations. Skogman stated that they have not looked at enforcement at this time.

Stanaway stated that the Public Health and Safety Board are concerned about life safety issues.

Skogman reported that landlords had shown up for the Public Hearing and the Commission requested that their suggestions be forwarded and that they be a part of the process. No suggestions were received and no participation was forthcoming from landlords.

Skogman is ready to forward the proposal to the City Council. Skalko stated in the present form and with no enforcement he would vote against it. Prebeg stated that safety should be the main concern.

Bob Brown stated that the City may want to look at a housing code instead of a rental

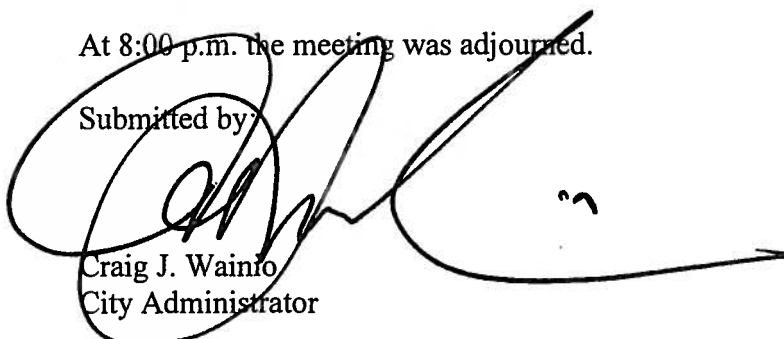
ordinance. Skogman requested that Brown forward some basic housing code information.

Waldron raised concerns over how this may affect the Fire Department and the strict implementation of the Uniform Fire Code would be cost prohibitive.

Prebeg would like the Commission to look at a basic housing code and to work with the Fire Department on safety issues. Skogman and Skalko concurred.

At 8:00 p.m. the meeting was adjourned.

MINUTES
MOUNTAIN IRON CITY COUNCIL
MARCH 19, 2012

Mayor Skalko called the City Council meeting to order at 6:34 p.m. with the following members present: Joe Prebeg, Jr., Tony Zupancich, Ed Roskoski, and Mayor Gary Skalko. Absent member included: Susan Tuomela. Also present were: Craig J. Wainio, City Administrator; Jill M. Anderson, Municipal Services Secretary; Alan Johnson, City Engineer; Michael Downs, Interim Public Works Director; John Backman, Sergeant; and Brian Lindsay, City Attorney.

The Mayor reminded the Council Members to follow the agenda and not bring up issues that that are not on the agenda.

It was moved by Skalko and seconded by Zupancich that the consent agenda be approved as follows:

1. Add the following item to the agenda:
VI. E. Interim Fire Captain position
2. Approve the minutes of the March 5, 2012, regular meeting as submitted.
3. That the communications be accepted and placed on file and those requiring further action by the City Council be acted upon during their proper sequence on the agenda.
4. To acknowledge the receipts for the period March 1-15, 2012, totaling \$160,500.21, (a list is attached and made a part of these minutes).
5. To authorize the payments of the bills and payroll for the period March 1-15, 2012, totaling \$345,664.15, (a list is attached and made a part of these minutes).

The motion carried on a roll call vote with Tuomela absent.

The Mayor reported on the following:

- Mountain Iron-Buhl High School Girls Basketball Team. Congratulations to the Team for winning 2nd place in the State Class A Tournament.
- Announcement. A benefit dinner is set for the Summer Work Outreach Program (SWOP) on Thursday, March 29, 2012, at the Mountain Iron Community Center.
- Hug a Ranger buttons. Saint Louis County developed the marketing program to promote the mining industry in Minnesota.
- MN/DOT Open House. A meeting is scheduled for Tuesday, March 27th, 4-8 p.m. regarding the relocation of Highway 53, at the Mountain Iron Community Center.

The City Administrator reported on the following:

- City housing lots for sale. Requested that interested people contact the City Hall or look at the City's web site for additional information.
- Wellhead Protection Plan. Representatives from the Department of Health met with the Administrator and the WWTP Lead Operator regarding the implementation of the plan.

- City web site redesign. By March 23, 2012, the new site should be implemented.
- Junior Curling Program at Curl Mesabi. He wanted to recognize the program and thank Dennis Jorgensen and his wife and daughter, who have worked very hard on the program. If anyone was interested, they could contact him and he would get them into the program.

The Library Director/Special Event Coordinator reported on the following:

- Library usage report. Presented the February 2012 report for circulation and attendance.
- Programs Presented: Brass Quintet Concert, Medicine Bag Program, and Magic School Bus Program. Works with the Legacy Arts Grant and many of the programs are at no cost to the City.
- Announcements: Tuesday, March 27, 2012, there will be an Art and Water Discovery Program. Thursday, March 29, 2012, there will be a professional puppet teller show called, “Night on Bear Island”.
- Special Events: Easter Egg Hunt–Saturday, April 7, 2012 at Merritt Elementary at noon. Merritt Days Celebration–August 10 and 11, 2012. The Merritt Days Committee meetings are held on the second Tuesday of every month.

The Sergeant reported that the Saint Louis County Sheriff’s Department has placed two new deputies in the Mountain Iron office, Mike Lorenz and Scott Hirsch.

It was moved by Prebeg and seconded by Zupancich to adopt Resolution Number 05-12, receiving report and calling hearing on improvement, for improvements to the Mountain Iron Water System along County Road 7, (a copy is attached and made a part of these minutes). The motion carried with Tuomela absent.

It was moved by Zupancich and seconded by Roskoski to approve the proposal from the Arrowhead Regional Development Commission for the facilitation and preparation of a Strategic Plan at a cost of \$7,666. The motion carried on a roll call vote with Tuomela absent.

It was moved by Prebeg and seconded by Zupancich to go on record accepting the layout proposed by United States Steel Corporation for the realignment of County Road 102. The motion carried with Roskoski voting no and Tuomela absent.

It was moved by Prebeg and seconded by Zupancich to contribute \$100 to the John Kauppinen Memorial Law Enforcement Scholarship Foundation with the funds coming from the Charitable Gambling Fund. After further discussion, Prebeg amended the amount to \$200 and Zupancich seconded it. The amended motion carried on a roll call vote with Tuomela absent.

It was moved by Zupancich and seconded by Prebeg to appoint William Copeland to fill the position for Fire Department Captain for the temporary vacancy made by Dustin Rabideaux

who is on leave until July. The motion carried with Tuomela absent.

The Council briefly discussed the proposed Rental Ordinance. The Mayor said that the consensus of the Council at the Committee-of-the-Whole meeting held on March 12, 2012, was to have a check list with some safety items for renters.

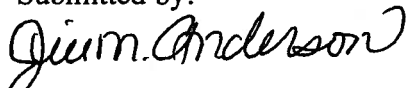

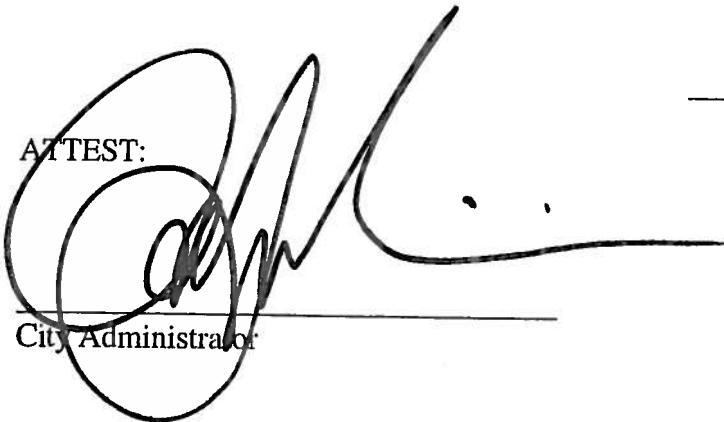

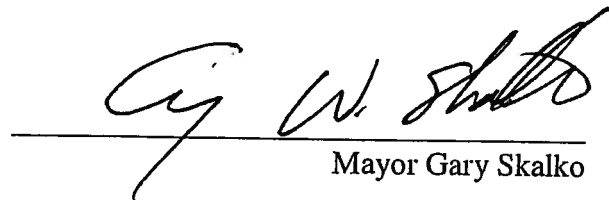
NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF MOUNTAIN IRON, MINNESOTA:

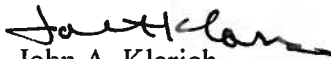

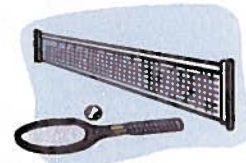

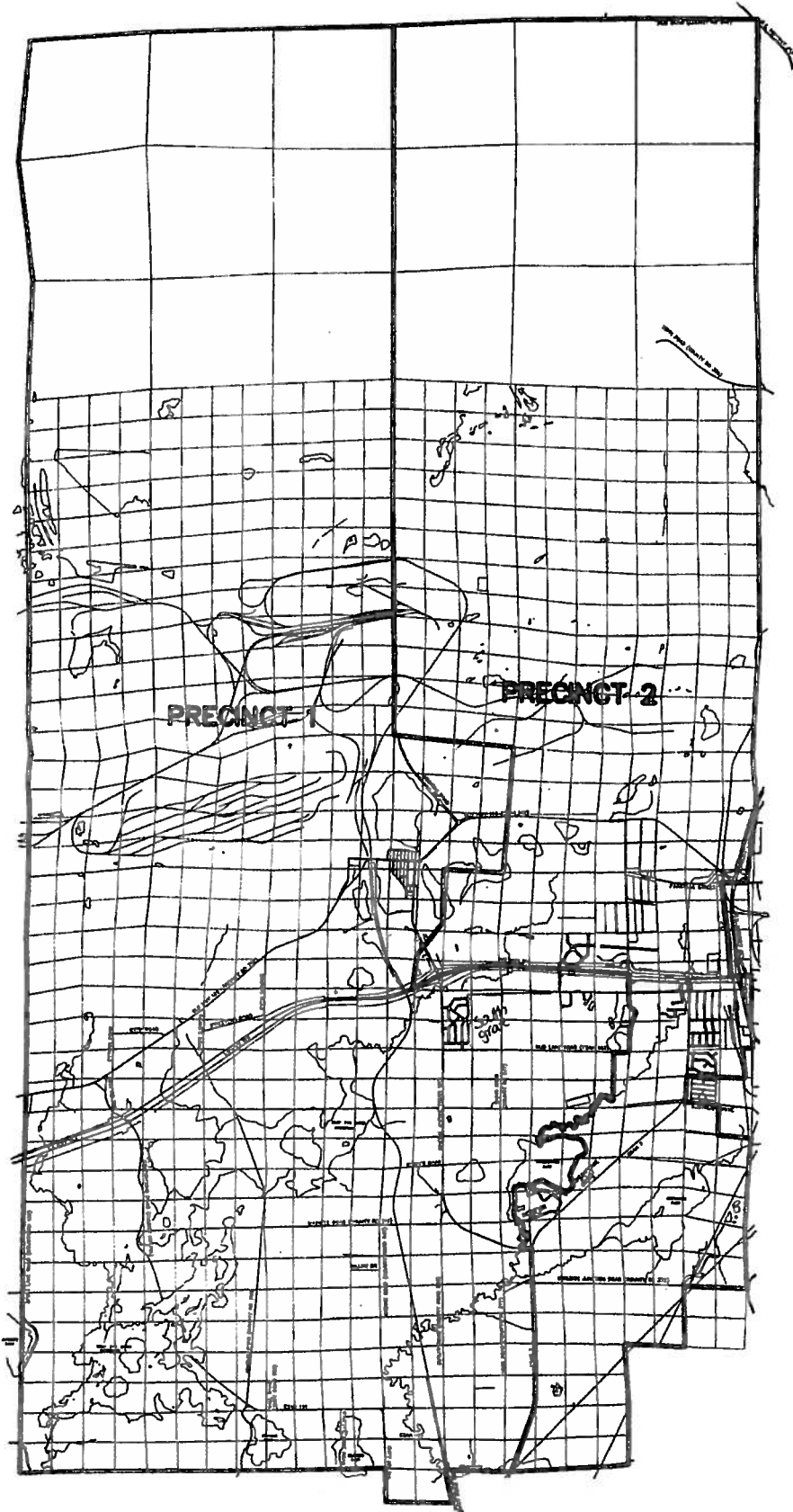

Lease Term - The term of this lease agreement will be concurrent with the premises permit issued by the Gambling Control Board (Board).

Management of Gambling Prohibited - The owner of the premises or the lessor will not manage the conduct of gambling at the premises.

Participation as Players Prohibited - The lessor will not participate directly or indirectly as a player in any lawful gambling conducted on the premises. The lessor's immediate family and any agents or gambling employees of the lessor will not participate as players in the conduct of lawful gambling on the premises, except as authorized by Minnesota Statutes 349.181.

Illegal Gambling

The lessor is aware of the prohibition against illegal gambling in Minnesota Statutes 609.75, and the penalties for illegal gambling violations in Minnesota Rules 7865.0220, Subpart 3. In addition, the Board may authorize the organization to withhold rent for a period of up to 90 days if the Board determines that illegal gambling occurred on the premises or that the lessor or its employees participated in the illegal gambling or knew of the gambling and did not take prompt action to stop the gambling. Continued tenancy of the organization is authorized without payment of rent during the time period determined by the Board for violations of this provision, as authorized by Minnesota Statutes 349.18, Subdivision 1(a).

To the best of the lessor's knowledge, the lessor affirms that any and all games or devices located on the premises are not being used, and are not capable of being used, in a manner that violates the prohibitions against illegal gambling in Minnesota Statutes 609.75.

Notwithstanding Minnesota Rules 7865.0220, Subpart 3, an organization must continue making rent payments under the terms of this lease, if the organization or its agents are found to be solely responsible for any illegal gambling, conducted at this site, that is prohibited by Minnesota Rules 7861.0260, Subpart 1, item H or Minnesota Statutes 609.75, unless the organization's agents responsible for the illegal gambling activity are also agents or employees of the lessor.

The lessor must not modify or terminate the lease in whole or in part because the organization reported, to a state or local law enforcement authority or the Board, the conduct of illegal gambling activity at this site in which the organization did not participate.

Other Prohibitions

The lessor will not impose restrictions on the organization with respect to providers (distributor or linked bingo game provider) of gambling-related equipment and services or in the use of net profits for lawful purposes.

The lessor, the lessor's immediate family, any person residing in the same residence as the lessor, and any agents or employees of the lessor will not require the organization to perform any action that would violate statute or rule. The lessor must not modify or terminate this lease in whole or in part due to the lessor's violation of this provision. If there is a dispute as to whether a violation occurred, the lease will remain in effect pending a final determination by the Compliance Review Group (CRG) of the Gambling Control Board. The lessor agrees to arbitration when a violation of this provision is alleged. The arbitrator shall be the CRG.

Access to permitted premises

Consent is given to the Board and its agents, the commissioners of revenue and public safety and their agents, and law enforcement personnel to enter and inspect the permitted premises at any reasonable time during the business hours of the lessor. The organization has access to the permitted premises during any time reasonable and when necessary for the conduct of lawful gambling on the premises.

Lessor records

The lessor must maintain a record of all money received from the organization, and make the record available to the Board and its agents, and the commissioners of revenue and public safety and their agents upon demand. The record must be maintained for 3-1/2 years.

Rent all-inclusive

Amounts paid as rent by the organization to the lessor are all-inclusive. No other services or expenses provided or contracted by the lessor may be paid by the organization, including but not limited to:

- trash removal
- electricity, heat
- snow removal
- storage
- janitorial and cleaning services
- other utilities or services
- lawn services
- security, security monitoring
- in the case of bar operations, cash shortages.

Any other expenditures made by an organization that is related to a leased premises must be approved by the director of the Gambling Control Board. Rent payments may not be made to an individual.

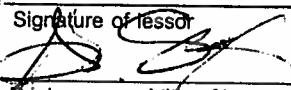

- **Ownership** - If a change in ownership occurs, the organization will submit a new lease to the Board within 10 days after the new lessor has assumed ownership.

Acknowledgment of Lease Terms I affirm that this lease is the total and only agreement between the lessor and the organization, and that all obligations and agreements are contained in or attached to this lease and are **subject to the approval of the director of the Gambling Control Board.**

The lease may be terminated by either party without cause with a 30-day written notice.

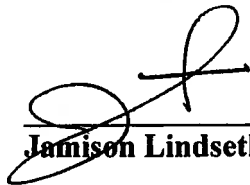

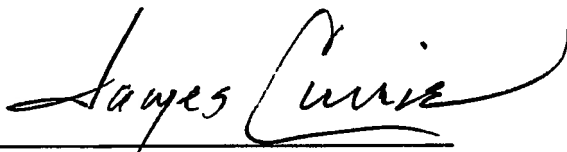

Supermajority Amendment Will Hurt Greater Minnesota

Greater Minnesota will be the loser if the state constitution is amended to require a supermajority in the legislature to approve or otherwise limit any legislative increases in taxes and expenditures. If that happens, constitutional budget amendments would become the norm, leading to budgeting by popular vote instead of a thoughtful, studied legislative process that balances revenues with expenditures.

**Greater Minnesota
legislators should vote
NO on supermajority
amendments.**

If the public passes a constitutional amendment that allows a minority of legislators to hold the budget process hostage, the majority will strike back by passing additional constitutional amendments, and greater Minnesota will be outgunned.

Population It will be easier to pass constitutional amendments that benefit the metro area because of its large, concentrated population base. It will be more difficult to pass constitutional amendments that help greater Minnesota.

Resources Promoters of programs with the money, resources and special interest backing needed to influence voters would prevail over programs supported by groups of people without those resources, and resources are slimmer in greater Minnesota.

If legislators can't increase taxes or expenditures on the state level, they will pass the cost on to other entities, especially those that can generate some revenues of their own, with the impact much more severe in greater Minnesota. The targets will be:

Cities Programs like Local Government aid would be swallowed up to pay for other state spending priorities. That would lead to property tax increases, and as we saw when Market Value Homestead Credit was eliminated, greater Minnesota homeowners and businesses would be the biggest losers.

Higher Education Rising tuition would keep many from obtaining a degree, but in less populated, primarily rural areas of the state, budget pressures could result in fewer class offerings or even the closing of institutions of higher education, further limiting educational opportunities in greater Minnesota.

Nursing Homes Nursing homes are often the biggest employer in smaller communities in greater Minnesota, but if aid is cut, many will be forced to close, eliminating needed jobs and separating residents from their families.

K-12 Education If education funding is reduced, school districts will be forced to go to voters for additional funding. That will create inequities by reducing educational opportunities for students in smaller, property-poor districts that can't raise taxes and causing steeper individual property tax increases in greater Minnesota communities than in some metro property-rich communities.

Did you know that without regard for race, area of residence or economic well-being, mild to severe mental illness afflicts one in five Americans each year? For one in twenty, the malady will persist with a seriously debilitating effect. These funds enable them to meet needs like medicine, housing, assistance with co-payments, assistance with proper hygiene and nutrition, as well as counseling and other therapy. With state and Federal cut backs, this fund has become increasingly critical to the members of our greater community.

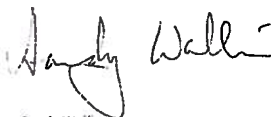

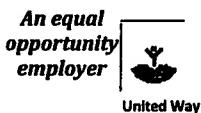
