MINUTES MOUNTAIN IRON CITY COUNCIL JULY 19, 2004

Mayor Skalko called the City Council meeting to order at 6:30 p.m. with the following members present: Joe Prebeg, Jr., Allen Nelson, Dale Irish, Ed Roskoski, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; Jill M. Forseen, Municipal Services Secretary; Don Kleinschmidt, Director of Public Works; Larry Nanti, Director of Parks and Recreation; Paul Cerkvenik, City Attorney; and Rod Flannigan, City Engineer (entering at 6:33 p.m.).

It was moved by Prebeg and supported by Nelson that the consent agenda be approved as follows:

1. Add the following items to the agenda:

- 2. Approve the minutes of the July 19, 2004, City Council meeting as submitted.
- 3. That the communications be accepted, placed on file, and those requiring further action by the City Council be acted upon during their proper sequence on the agenda.
- 4. To acknowledge the receipts for the period July 1-15, 2004, totaling \$760,854.52, (a list is attached and made a part of these minutes).
- 5. To authorize the payment of the bills and payroll for the period July 1-15, 2004, totaling \$350,247.53, (a list is attached and made a part of these minutes).

The motion carried on the following the following roll call vote: Prebeg, yes; Nelson, yes; Irish, yes; Roskoski, no; and Skalko, yes.

At 6:32 p.m., it was moved by Prebeg and supported by Nelson to recess the regular meeting and open the public hearing on the Community Development Block Grant Application. The motion carried.

Councilor Roskoski expressed concern with the pit being labeled as a pond. The Administrator said that the people that review the grant live in Virginia and are aware of the pit.

There was no further discussion and no communications were received regarding the public hearing.

At 6:34 p.m., it was moved by Prebeg and supported by Nelson to close the public hearing and reconvene the regular meeting. The motion carried.

It was moved by Skalko and supported by Irish to authorize a payment of \$240 for the Girls Softball Program, for girls 14 years and under. And further, to advise Mr. Taus to communicate with the City Staff during budget time so the appropriate funds can be allocated. The motion carried on the following roll call vote: Nelson, no; Irish, yes; Roskoski, yes; Prebeg, yes; and Skalko, yes.

It was moved by Skalko and supported by Prebeg to authorize the Festival of Trees to utilize the Community Center in November, 2004 charging them a total rental amount of \$450. The motion carried on the following roll call vote: Irish, yes; Roskoski, yes; Prebeg, yes; Nelson, no; and Skalko, yes.

The Council review the letter received from Tara and Jeremy LaMourea regarding their concerns on the use of Grant Avenue and the odor from the Waste Water Treatment Plant.

It was moved by Roskoski and supported by Irish to direct the Administrator to contact two different appraisers to obtain two appraisals on the following properties:

- 1) the Messiah Lutheran Church property, 11 acres parcel at the intersection of Mineral Avenue and Highway 169;
- 2) the tailing pond, USX property, 125+ acres, with the valuation of the old dump being there, as is. And also, what the valuation would be if the old garbage dump was removed.

After further discussion, Councilor Roskoski withdrew his motion and Councilor Irish withdrew his support.

Councilor Roskoski asked if the City had heard from the City of Virginia on the joint paving project for 16th Avenue. The Administrator said that the City of Virginia had been contacted, but they have not responded to the request.

It was moved by Prebeg and supported by Nelson to accept the recommendation of City Staff and authorize the purchase of electrical equipment for the substation upgrade to Border States Electric at their low quote of \$10,566.78. The motion carried unanimously on a roll call vote.

It was moved by Prebeg and supported by Skalko to authorize the Blight Officer to work with the Sheriff's Department and the City Attorney to determine whether an imminent and serious hazard to human life or safety exists at the Parkville School, to serve notice to the property owner, and to post a notice at the property for the August 2, 2004, City Council meeting. The motion carried.

Councilor Irish questioned the Recreation Director regarding the location of the new bench at Nichols Hall. Councilor Irish also pointed out that the handicapped ramp is in need of maintenance, the basketball nets need replacing, the light shining on the flag is broken out, and

the roof vent on the gabriel end of the roof is broken out and needs to be repaired. Also, the Parkville baseball field fencing is falling down and needs to be repaired.

It was moved by Nelson and supported by Prebeg to accept the recommendation of the City Engineer and award the contract for the Water Treatment Plant backflush tank to the low bidder, Hibbing Excavating, Inc., in the amount of \$35,362.00 with the funds to be expended from the Water Treatment Plant Fund. The motion carried unanimously on a roll call vote.

It was moved by Roskoski and supported by Irish to have a study completed by Benchmark Engineering to supply the City Council with maps, charts, and any other necessary materials for the following area: the USX East tailing pond area. With the report to include build able area, various traffic access routes with projected costs, utility accessibility options with projected costs, a map indicating the wetland that are involved, and a topographic map of the specific tailing pond in relation to everything around there between Mineral Drive and the railroad tracks and General Electric and Slate Street. The motion carried on the following roll call vote: Nelson, no; Irish, yes; Roskoski, yes; Prebeg, no; and Skalko, yes.

Councilor Roskoski asked how Benchmark was doing on analyzing the sewer plant noise problem. The City Engineer stated that there were no monitoring reports completed at this time, they just checked on the Wastewater Treatment Plant property.

Councilor Roskoski questioned why the Marion Drive cul-de-sac was not reclaimed and was just overlayed. The City Engineer said that a second coat would be applied soon.

Councilor Roskoski inquired when the North Court overlay was going to be completed. The Engineer stated that it was supposed to be completed already, so it would be done soon.

It was moved by Roskoski and supported by Skalko to direct the Recreation Director to contact Tom Cvar and advise him that the Council would be retaining the land until an alternative site could be found for the sliding hill and skating rink. After further discussion, Councilor Roskoski withdrew his motion and Mayor Skalko withdrew his support.

It was moved by Nelson and supported by Prebeg to set a public hearing for the vacation of a portion of Missabe Avenue between Outlot A and Block 1 of Merritt's First Addition to Mountain Iron for August 16, 2004. The motion carried.

Councilor Roskoski asked the City Attorney whether they have made any progress on information to set up a Mountain Iron Endowment Fund. The City Attorney said that he was not clear as to what the Council wanted regarding the information on the Foundation.

It was moved by Roskoski and supported by Irish to have the City of Mountain Iron work with the Library Architect, Erik Wedge, and Com Con Representatives to work out a change order and exchange the brown roof tiles for the historically correct pale orange color roof tiles with the City paying the difference for the change order. The **motion failed** on the following roll call vote: Irish, no; Roskoski, yes; Prebeg, no; Nelson, yes; and Skalko, no.

It was moved by Roskoski and supported by Skalko to direct the Librarian to notify any City Council Members that were interested in receiving a Library Board meeting packet, the Library Board City Council Liaison, and have the information sent out in advance of the meeting. The motion carried.

It was moved by Skalko and supported by Irish to adopt Resolution Number 28-04, Community Development Block Grant application, (a copy is attached and made a part of these minutes). The motion carried.

It was moved by Nelson and supported by Irish to adopt Ordinance Number 04-04, amending Chapter 22, (a copy is attached and made a part of these minutes). The motion carried.

It was moved by Irish and supported by Roskoski to authorize a donation of \$300 to the ATV Club with City Staff maintaining the funds and tracking the expenditures. The motion carried on the following roll call vote: Roskoski, yes; Prebeg, yes; Nelson, no; Irish, yes; and Skalko, yes.

At 8:19 p.m., it was moved by Roskoski and supported by Prebeg that the meeting be adjourned. The motion carried.

ORDINANCE NUMBER 04-04

AMENDING CHAPTER 22 OF THE MOUNTAIN IRON CITY CODE

THE CITY COUNCIL OF MOUNTAIN IRON ORDAINS:

SECTION 1. AMENDING SECTION 22.02. Section 22.02, Definitions, is hereby amended to include the following:

BED AND BREAKFAST — A single family dwelling in which transient guest rooms are rented on a nightly basis for periods of seven (7) days or less and where at least one (1) meal is offered in connection with the provision of sleeping accommodations only.

SECTION 2. AMENDING SECTION 22.05. Section 22.05, Subdivision 3, is hereby amended to include the following as item M.

M. Bed and Breakfast Homes

<u>SECTION 3. AMENDING SECTION 22.06.</u> Section 22.06, Subdivision 3, is hereby amended to include the following as item G.

G. Bed and Breakfast Homes

<u>SECTION 4. AMENDING SECTION 22.07.</u> Section 22.07, Subdivision 3, is hereby amended to include the following as item F.

F. Bed and Breakfast Homes

SECTION 5. ADDING SECTION 22.18. Section 22.18 is hereby added to Chapter 22 of the Mountain Iron City Code and shall be titled Bed and Breakfast Homes and shall include the following:

- Subd. 1. Bed and Breakfast homes may be allowed by conditional use, subject to the following standards:
 - A. The owner shall reside in the Bed and Breakfast Homes and manage the premises.
 - B. The establishment shall comply with State Health and Building Code requirements.

- C. Meals may be served to guests only
- D. No cooking or cooking facilities shall be allowed or provided in the guest rooms.
- E. The establishment shall be limited to four (4) guest rooms.
- F. Each guest shall be limited to staying not more than seven (7) days within any thirty (30) day period.
- G. The owner shall maintain a guest register showing the name, address, motor vehicle license number, and inclusive dates of visits of all guests.
- H. The owner shall supply a parking plan with the application for a Conditional Use Permit
- I. Signage for each Bed and Breakfast property shall be limited to one non-illuminate sign per property, flaying a maximum sign area of four (4) square feet and a height not exceeding five (5) feet. Signs must run parallel with the Bed and Breakfast.
- J. There shall be no external vending machines.
- K. Sales of souvenirs and items representative of the area shall be accessory to the B&B and shall be restricted to sales to overnight guests only.
- L. Residential Appearance and Character. Each property shall maintain an exterior residential appearance and character, meaning an exterior façade that is compatible with the surrounding single family or duplex houses, and is, of an appearance that would be found in a structure designed for and occupied by a family as detached single or two-family residence.
- M. The initial conditional use permit for a Bed and Breakfast shall be valid from the date of issuance until January 31 of the following year. All conditional use permits for Bed and Breakfast's shall be reviewed by the Planning and Zoning Commission on the date of the first regularly scheduled January Planning and Zoning Commission meeting.
- N. All conditional use permits granted for a Bed and Breakfast are non-transferable.

CITY OF MOUNTAIN IRON GUIDELINES FOR CITY MOWING

CITY RESPONSIBILITY

The City of Mountain Iron will only be responsible for mowing grass along City street right-of-ways and City-owned property.

AMOUNT OF MOWING

Roadways will be mowed at least twice a year.

Parks and other City-owned property will be mowed when grass length is between four and six inches (4-6") in length, cut down to a two inch (2") minimum.

Mowing around Community Center will be as follows:

- Mow to the bottom of the east slope on the east side of the Community Center.
- Mow to the bottom of slope or 12 feet, whichever is less on the south of the building and parking lot.
- Mow to 12 feet north of the north curb line on the north side of the Community Center.

Property owners are responsible for lawn mowing up to the curb/paved or gravel roadways in all platted areas of the City.

Property owners are responsible for lawn mowing any boulevard between the sidewalks and curb/paved or gravel roadway.

The City will mow, at least twice, the shoulder areas from the paved/gravel portion down to the bottom of any ditch or if no ditch is present, to the width of no more than one pass of the large mower in all non-platted areas of the City.

It will be at the discretion of the Director of Public Works to decide if specific grass trimming and clean-up are required.

All City ball fields will be mowed and cared for at the discretion of the Director of Parks and Recreation.

BRUSH AND HEDGES

All brushes and hedges on City property, easements or right-of-ways will be cut and trimmed at necessary intervals to maintain a level of neatness and to prevent blockage of sight lines for vehicle drivers.





Dear Craig Wanio & Mt. Iron City Council Members:

We have a few concerns that we would appreciate you taking the time to look into.

We live at 8804 Grant Drive and our road was just paved about a month ago. We have noticed that the large City trucks have been hauling different items (concrete, asphalt, ect) and dumping them down by the sewage plant. We are concerned that our newly paved road is going to be ruined with the amount of hauling and weight of these trucks. We are questioning if there is another place where these items can be hauled to.

We also have another concern regarding the sewage plant. We notice that on more than one time during the week there is a very strong, distinctive odor from the plant. We realize that there is going to be some smell associated with the plant, but we don't believe that it should be this bad. Usually we notice the strong odor in the afternoons, and it lasts for hours (6 or more). We also notice it when the truck comes to pump out the tanks at the plant. We are questioning if there are things that are not working properly in the plant, or if there is some other explanation for the odor. We have lived next to the plant for 6 years, and up until recently, we have not had an issue with the odor. There must be an explanation why all of a sudden we are getting this strong odor. The odor is so strong, that we are unable to open our windows on these days and don't care to be outside in our yard. We are assuming that the MPCA has regulations and standards that need to be complied with.

We would appreciate feedback on these issues as soon as possible. I have talked to Mayor Skalko on these issues as well.

Thanks for your time and consideration with these issues.

SMALL CITIES UPDATE July 21, 2004

Despite need, prospects dim for special session

The LGA glitch, which has left many city officials scratching their heads, is contributing to the growing clamor over the need for a special session. Due to a drafting error in the LGA provisions in the 2003 special session tax bill, over 600 cities will be in the position of either trying to scrape by with less state aid than anticipated or wondering whether or not they can actually spend the "bonus" they will receive.

Last session, both the House and Senate recognized the problem. Unfortunately, the tax committees never met jointly in conference committee, so the problem will remain unresolved unless one of two things happens. First, the Governor could institute a short-term fix by following "legislative intent" rather than the letter of the law. Second, the Governor could call a limited special session to correct the problem. However, neither seems likely. The Governor instituted the short-term fix last session, but is unwilling to do so again. Likewise, he is reluctant to call a special session unless there is prior agreement over the agenda.

Please contact your legislators, the House and Senate leadership and the Governor, asking them all to agree to meet in special session over at least this issue. House candidates are out on the campaign trail right now, but tell incumbents they should be beating a path to the Capitol, instead. There's still work to be done, including a much-needed bonding bill.

Policy positions on the docket at LMC Regional Meetings

The League of Minnesota's Regional Meetings started this week — the first ones to be held in the middle of summer. This change was made in order to get more people involved in their policy adoption process, so we hope many of you can take part in the meetings. As you know, there was some controversy last year over the League's position on cuts in state aid to cities, so we expect a lot of discussion on that topic. Some points to remember when discussion focuses on this area are:

- No more LGA cuts in 2005 The State is facing another budget deficit, but LGA was already cut excessively and unfairly in 2003. It received the only permanent aid cuts even though LGA is not the only property tax relief program affecting cities. However, it is the only program based on need.
- Restore \$60 million of LGA funding in 2005 The excessive and unfair LGA cuts in 2003 resulted in major service cuts and property tax increases in the poorest and neediest cities in the state, but restoring \$60 million of LGA in 2005 would help fix the problem.
- **Priority funding for LGA** LGA funding should be given priority over the funding for the Market Value Credit and transit property tax relief, which are not based on a city's need or tax base.

MAOSC Annual Conference a success

In June, MAOSC joined forces with the University of Minnesota Morris and its *Center for Small Towns* in showcasing the successes of small cities. By combining our conference and the University's annual symposium, we also brought attention to the needs of small cities. The Legislative forum, which was sponsored by MAOSC, was a real eye-opener for those not used to seeing legislators in action. The

questions asked – and the audience's frustration over last session's lack of progress and the gamesmanship demonstrated on the panel – should have sent the legislators scurrying back to St. Paul to finish up their work. Unfortunately, that has not happened.

During the forum, questions flew in fast and furious. Unfortunately, the hour and a half allotted to the forum went by just as quickly, so most questions were left unanswered. Since audience members were anxious to hear more, we collected and sent the questions to the panel members, asking them to send in their responses. So far, we have only had one person follow through, and that was Senate Majority Leader Dean Johnson (D-Willmar). The process is slow, but by agreeing to take part in joint meetings over the interim, city and township lobbyists are hoping to make some progress in finding a solution to our long simmering battles over annexation and related land use issues. This is a tough issue for cities, since we are generally pleased with the annexation process now in place. However, the townships are looking for at least some changes that benefit their members, and they are flexing their muscles. They have been denied meaningful legislative hearings for years, and they've got a strong cadre of legislators waving the flag for them and calling for action. With that as an impetus, we are hoping that by the start of the next legislative session we have proposals that include some give and take on both sides. We also plan on developing a handbook that can be used to initiate meaningful dialogue between city and township officials – hopefully prior to annexation disputes.

Dear Mr. Wainio:

I am happy to inform you that the Mountain Iron Public Library Accessibility grant application suspension has been removed. I will immediately proceed processing the grant agreement.

Estimate the number of weeks or months to complete the project. Additionally, please provide the names and addresses of the state senator(s) and representative(s) whose districts will benefit from this project. Please provide me with this information within five working days.

You will not hear from me for several weeks while the Department of Education processes the grant application. To expedite the process, I have attached a grant agreement template that the City of Mountain Iron will enter into with the State of Minnesota. The City of Mountain Iron will receive an identical document for official signature. Although the document is referred to as a grant agreement, think of it as a contract. Therefore, I recommend that the Mountain Iron city attorney review this template on behalf of the City of Mountain Iron and City officials understand its requirements.

For the official copy, please provide me with the name and position that will appear on page 18. The City of Mountain Iron will complete pages 21, 22, and 23. I will insert a copy of the City Council resolution for page 24, unless your policies require an additional vote. In any case, an original certification for the accepting resolution is required on page 25 for each of four copies you will receive. Amendment D (indicated on page 26) will be the grant proposal.

This letter is only advisory and not an official commitment. The City of Mountain Iron must not expend money related to the accessibility project until it receives a completed grant agreement with the Commissioner's signature.

Governor reverses LGA interpretation

At a press conference on Thursday, Governor Tim Pawlenty announced that he would end the confusion surrounding a 2003 LGA drafting error by agreeing to certify the 2005 Local Government Aid (LGA) distribution based on legislative intent. The governor's decision, which came only days before the Department of Revenue is required by law to certify the 2005 LGA distribution to each city, followed an intense effort by the League and cities across the state to convince the governor and legislative leaders to ignore the drafting error and follow legislative intent or correct the error in a special session.

The governor's decision will make the administration of the LGA formula consistent with the intent of the legislature and consistent with the 2004 LGA distribution. For the 2004 LGA distribution, the governor accepted letters from the chairs of the House and Senate Tax committees highlighting the error and urging the governor to follow the legislature's intended outcome. After the legislature failed to correct the error during the 2004 session, the governor reversed course citing a legal interpretation that failure of the legislature to correct the mistake had effectively changed legislative intent.

Over the past two months, the LGA error has evolved into a major issue as cities across the state have been developing their budgets for 2005. Some legislators indicated that if the problem was not corrected before the LGA certifications were distributed to cities in August, they would correct the error early in the 2005 session. Delaying the resolution until next year would not have allowed cities to make necessary adjustments to their property tax levies and as a result, some cities might have budgeted for higher than necessary property taxes or other revenue sources while other cities might have planned for more LGA than they would have received with a delayed fix to the error.

In his Thursday announcement, the governor stipulated that his decision would be based on agreement from the League of Minnesota Cities and other groups that represent cities before the legislature to urge each organization's members to support the decision and not take legal action against the state to dispute this legislative intent interpretation of the law.

Thursday afternoon, the LMC Executive Committee acted on behalf of the LMC Board of Directors and responded affirmatively to the governor's request. The League cannot make commitments on behalf of member cities, but the Executive Committee members hoped that for the common good of the city community, all cities would support legislative intent. The League will also be pressing legislators to correct the statutory error early in the 2005 session.


The Executive Committee took this action in keeping with the LMC Board's unanimous decision in June to urge the governor to distribute the 2005 LGA dollars based on legislative intent or call a special session to correct the error. The Board took this position understanding that a letter-of-the-law interpretation would have redistributed LGA dollars to the advantage of some municipalities and to the disadvantage of others.

The Board weighed this difference in impact within the League membership very carefully. They determined that many statements and actions by legislators made it clear that the law as it stands does not represent what was intended - a technical error was made. The Board also felt that while some cities would have potentially received an unexpected, likely one-time, windfall from a letter-of-the-law interpretation, there was a slim chance that this extra aid would ever materialize. On the other hand, those cities that stood to lose a great deal of aid under a letter-of-the-law interpretation would have a harder time budgeting and setting levies based on legislators' promises to fix the issue next session. The Board believed that there was a need for both advantaged and disadvantaged cities to have greater certainty during their budget process in regard to the 2005 LGA distribution.

We believe the governor's decision will clarify the LGA distribution for 2005 and make the budgeting process more predictable. Although a legal challenge could yet occur, given the ambiguities of the law it is uncertain whether such a suit would be successful.

Dear Members:

Since we wrote a letter to Governor Pawlenty urging him to do something to ease the pressure on cities, it is only right to share the response. In the RAMS letter, we asked him to interpret the Local Government Aid Distribution Law as he did last year, or call a Special Session to pass the bill that all parties had agreed to during the regular session.

He did not respond by letter, but he did agree to use the interpretation he used last year. Our area would have lost about \$3 million had he not done that. He does however continue to cater to a single interest group by not calling a Special Session until they get their way.

While we are grateful for the decision he made in regard to the L.G.A., there are still issues that a Special Session could address that would benefit the Taconite Relief Area. Among those are a Bonding Bill that could benefit our area by \$10 million, the Taconite Aid offset, and Revenue Recognition for school districts, which was also agreed to for passage at the end of session.

As events develop and materialize I will update you.
