MINUTES MOUNTAIN IRON CITY COUNCIL SEPTEMBER 3, 2013

Mayor Skalko called the City Council meeting to order at 6:30 p.m. with the following members present: Joe Prebeg, Jr., Susan Tuomela, Tony Zupancich, Alan Stanaway, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator; Jill M. Clark, Municipal Services Secretary; Michael Downs, Director of Public Works; Rod Flannigan, City Engineer; Sally Peterangelo, Library Director/Special Events Director; and John Backman, Sergeant.

It was moved by Skalko and seconded by Tuomela that the consent agenda be approved as follows:

- 1. Add the following item to the agenda:
 - a. VI. I. Request to serve alcohol at the Community Center
 - b. Move Item IV.G. Planning & Zoning Commission to the first items on IV.
- 2. Approve the minutes of the August 19, 2013, regular meeting as submitted.
- 3. That the communications be accepted and placed on file and those requiring further action by the City Council be acted upon during their proper sequence on the agenda.
- 4. To acknowledge the receipts for the period August 16-31, 2013, totaling \$2,283,335.57, (a list is attached and made a part of these minutes).
- 5. To authorize the payments of the bills and payroll for the period August 16-31, 2013, totaling \$491,882.88, (a list is attached and made a part of these minutes).

The motion carried unanimously on a roll call vote.

During the public forum, Deneen Gunderson spoke regarding issues they were experiencing with the lot they purchased in South Forest Grove. She also asked what could be done to allow her husband to come to the City Hall without an escort. She also covered several issues with regard to their purchase of Lot 18 in South Forest Grove. She said that the cost for the electrical hookup was more than they were advised when they purchased the lot, there were no street lights installed, the corner pin was missing from their lot, and the gas lines have not been put in yet.

Councilor Zupancich suggested that City Staff develop a welcome package for new residents moving in to Mountain Iron and for those that have purchased lots in the City owned additions.

Daniel Schultz, retired from Minnesota Power, now working for JDI Contracts Incorporated, said he was able to work with the Director of Public Works on the proposal for the substation.

At 6:53 p.m., it was moved by Zupancich and seconded by Tuomela to recess the regular meeting and open the public hearing on the vacation of Commerce Street and a portion of Park Ridge Drive pursuant to Minnesota Statute 412.851. The motion carried.

Councilor Zupancich said that this public hearing was for the relocation of County Road 102 for the new U. S. Steel entrance. He also said that there would be no City money spent on this road.

No one spoke during the public hearing and no communications were received.

At 6:54 p.m., it was moved by Zupancich and seconded by Tuomela to adjourn the public hearing and reconvene the regular meeting. The motion carried.

It was moved by Zupancich and seconded by Stanaway to accept the recommendation of the Planning and Zoning Commission and authorize the variance for Pentti Mahonen, 4929 Spirit Lake Road, Mountain Iron, parcel 175-0058-00080, for the installation of a septic system with a 75 foot setback from the lake. The motion carried unanimously.

It was moved by Stanaway and seconded by Tuomela to accept the recommendation of the Planning and Zoning Commission and authorize the variance for Ben and Marilyn West, 4919 Spirit Lake Road, Mountain Iron, parcel 175-0058-0090, for the installation of a septic system with a 75 foot setback from the lake. The motion carried unanimously.

The Mayor reported on the following:

- > Condolences to the following families. Gladys Smith, Norman Niskanen, and George Teska.
- > Fall Sports. He wished all the fall boys and girls sport activities a successful season.
- > Sale of Lots. He advised the Council that another lot was sold in Unity Second Addition, making a total of 15 lots sold. He said that South Forest Grove has four lots sold.

It was moved by Prebeg and seconded by Zupancich to approve the agreement with the AEOA Energy Assistance Program, (a copy is attached and made a part of these minutes). The motion carried unanimously.

It was moved by Stanaway and seconded by Tuomela to accept the recommendation of the Public Health and Safety Board and begin condemnation proceedings for a residence at 5472 Bluebell Avenue, Mountain Iron. The motion carried unanimously.

It was moved by Zupancich and seconded by Tuomela to authorize the gas service agreement with Minnesota Energy Resources to install gas service to South Forest Grove with the cost not to exceed \$8,000. It was moved by Zupancich and seconded by Tuomela to amend the motion to include seeking reimbursement from the Economic Development Authority for the expenses. The amended motion carried unanimously on a roll call vote.

It was moved by Prebeg and seconded by Zupancich to award the quote for the hazardous substance removal and demolition of the following properties:

8863 Quartz Avenue 5681 Mineral Avenue 8786 Arbor Lane 5620 Falcon Avenue

to Grivette Environmental Management, LLC for the hazardous substance removal in the amount of \$12,000 and G-Men from Ely for the demolition for \$33,247. The motion carried unanimously on a roll call vote.

It was moved by Zupancich and seconded by Tuomela to approve the agreement with the Wisconsin Energy Conservation Corporation (WECC) to provide a residential Conservation Improvement Program (CIP) for the City of Mountain Iron. The motion carried unanimously.

It was moved by Prebeg and seconded by Tuomela to approve the bid for the construction of a substation, in accordance with the City's voltage modification plan and due to the relocation of County Road 102, to Minnesota Power in the amount of \$486,000. The motion carried unanimously on a roll call vote.

The Director of Public Works thanked Daniel Schultz for assisting with the planning and design of the voltage modification plan.

It was moved by Zupancich and seconded by Prebeg to direct Benchmark Engineering to proceed with the sanitary lift station study at a cost not to exceed \$11,869, plus reimbursable expenses not to exceed \$600. The motion carried unanimously on a roll call vote.

The Director of Public Works informed the Council that City Staff would begin installing the street lights in the South Forest Grove Addition now that houses were being constructed in the area.

The Library Director/Special Events Coordinator reported on the following:

- Monthly Report. She submitted her August, 2013 Library report to the Council.
- ➤ Winter Hours. She reminded everyone that the Library had now switched to their winter hours with the Library now closed on Fridays and open on Saturdays from 10 a.m. until 2 p.m.
- > Pre-School Story Time. Would be starting soon.
- > Tea on Tuesday. Would be starting soon.
- > On-Line. They are starting an on-line book club.
- > Old Pictures. City Staff has hung up some of the old antique pictures in the Library.
- Merritt Days. She submitted information regarding the celebration to the City Council. She said the event was a total success and she thanked the City for their support of the event.

It was moved by Prebeg and seconded by Tuomela to authorize payment request number one to Ulland Brothers Incorporated for the County Road 102 Utility Extension Project in the amount of \$293,444.84. The motion carried unanimously on a roll call vote.

It was moved by Stanaway and seconded by Tuomela to authorize payment request number one to Hibbing Excavating Incorporated for the Unity Drive Improvement Project in the amount of \$25,299.45. The motion carried unanimously on a roll call vote.

It was moved by Zupancich and seconded by Stanaway to authorize the first and final payment request to AAA Striping Service Company for the 2013 Striping Improvement Project in the amount of \$9,844.00. The motion carried unanimously on a roll call vote.

During the liaison reports, Councilor Zupancich, representing the Planning and Zoning Commission, informed the Council that a citation was issued, for a violation to the Zoning Ordinance, for operating a commercial business off of the Vern's Greenhouse property. The City is working with the individual to assist him in relocating.

It was moved by Prebeg and seconded by Zupancich to adopt Resolution Number 24-13, accepting work for the Bluebell and Daffodil paving project, (a copy is attached and made a part of these minutes). And further, to stipulate that the City Engineer work with Mesabi Bituminous to complete the necessary repairs. The motion carried unanimously.

It was moved by Zupancich to approve Resolution Number 30-13, vacating Commerce Street and part of Park Ridge Drive in the Rock Ridge Development. After further discussion, Zupancich withdrew his motion.

It was moved by Zupancich and seconded by Tuomela to table Resolution Number 30-13, vacating Commerce Street and part of Park Ridge Drive in the Rock Ridge Development. The motion carried.

It was moved by Zupancich and seconded by Tuomela to adopt Resolution Number 31-13, approving the proposed 2013 tax levy, collectable in 2014, representing a zero percent levy increase, (a copy is attached and made a part of these minutes). The motion carried unanimously.

It was moved by Prebeg and seconded by Stanaway to adopt Resolution Number 32-13, adopting the 2014 market rate based referendum levy for the General Obligation Community Center bonds and interest, (a copy is attached and made a part of these minutes). The motion carried unanimously.

It was moved by Zupancich and seconded by Tuomela to adopt Resolution Number 33-13, concerning the 2013 Economic Development Authority Tax Levy, (a copy is attached and made a part of these minutes). The motion carried unanimously.

It was moved by Zupancich and seconded by Tuomela to adopt Resolution Number 34-13, calling a hearing on proposed assessments for the County Road 7 Water Main Extension Project, (a copy is attached and made a part of these minutes). The motion carried unanimously.

It was moved by Zupancich and seconded by Tuomela to set a public hearing for Monday, December 2, 2013, at 6:30 p.m. for public input on the 2014 budget and levy. The motion carried unanimously.

It was moved by Zupancich and seconded by Stanaway to adopt the Master Road Agreement between the City, the Economic Development Authority, and U. S. Steel Corporation, as submitted. The motion carried unanimously.

It was moved by Prebeg and seconded by Tuomela to approve the release of access agreement between the City of Mountain Iron and the Mountain Iron Economic Development Authority, as presented. The motion carried unanimously.

It was moved by Skalko and seconded by Tuomela to authorize Mac's Bar, Inc., dba: Mac's Bar, to serve alcohol at the Sopp Wedding Reception on September 14, 2013, at the Mountain Iron Community Center. The motion carried unanimously.

The Council reviewed the list of communications. The City Administrator announced that the Greater Minnesota Agency informed the City that the 2014 Blue Cross/Blue Shield renewal would have a small increase of 1.5%.

At 7:46 p.m., it was moved by Zupancich and seconded by Tuomela to recess the regular meeting and enter into a closed meeting to discuss negotiation with management personnel, following a 10 minutes recess. The motion carried unanimously on a roll call vote.

Mayor Skalko called the closed meeting to order at 7:57 p.m. with the following members present: Joe Prebeg, Jr., Susan Tuomela, Tony Zupancich, Alan Stanaway, and Mayor Gary Skalko. Also present were: Craig J. Wainio, City Administrator.

The Council discussed the management contract negotiations for Sally Peterangelo.

At 8:34 p.m., it was moved by Zupancich and seconded by Tuomela that the closed meeting be adjourned and reconvene the regular meeting. The motion carried unanimously.

It was moved by Zupancich and seconded by Stanaway to approve the management contract for Sally Peterangelo, Library Director/Special Events Coordinator, as presented. The motion carried with Prebeg and Tuomela voting no.

At 8:38 p.m., it was moved by Skalko and seconded by Tuomela that the meeting be adjourned. The motion carried unanimously.

Minnesota Energy Assistance Program FFY 2014

Agreement Between Energy Vendor and Service Provider

MOUNTAIN IRON CITY OF PUBLIC UTLITIES, 8586 ENTERPRISE DR S MT IRON MN 55768 and successor home energy providers, hereafter referred to as "the energy vendor", hereby agrees to cooperate with <u>Arrowhead Economic Opportunity Agency ~AEOA</u> hereafter referred to as "the Service Provider", and the Minnesota Department of Commerce (MDOC), Energy Assistance Programs, hereafter referred to as "the State" to deliver the Minnesota Energy Assistance Program for Federal Fiscal Year 2014 (FFY 2014), October 1,2013 through September 30, 2014.

I. The energy vendor and the Service Provider will:

- 1. Follow Energy Assistance Program (EAP) policies and procedures in the EAP Policy Manual (In particular Chapter 3).
- 2. Maintain accurate client and consumption information.
- 3. Comply with the Minnesota Government Data Practices Act (MGDPA), Minn. Stat. Ch. 13, as it applies to all data provided by the State under this agreement and as it applies to all data created, collected, received, stored, used, maintained or disseminated by the energy vendor or the Service Provider, in performing the duties under this agreement. In the administration of this program, the energy vendor and the service provider have access to a protected data base containing private information on individuals protected under the MGDPA. The energy vendor and the Service Provider agree to not release any private data, including from the database, to any third party without written authorization from the subject of the data.
- 4. Share information with each other as needed to perform the duties under this agreement.
- 5. Negotiate for continuation or reconnection of service to households determined eligible for EAP Primary Heat and EAP Crisis Benefits.
- 6. Establish a dispute resolution process to resolve issues arising during the term of this agreement.
- 7. Collaborate and do everything possible to ensure the customer has continuous access to home heating.
- 8. Minimize the risks of a customer's home energy crisis through the use of the Crisis Benefits.
- 9. Encourage regular payments from the household.
- 10. Collaborate to reduce home energy costs.
- 11. Work together to ensure EAP payments are appropriately applied to accounts and used for EAP services as designated by the Service Provider.

II. The Service Provider will:

- 1. Determine customer eligibility.
- 2. Provide new and existing energy vendors with information about the eHEAT software system.
 - Encourage all energy vendors to become an eHEAT user, allowing them access to eligibility and benefit data "online".
 - Provide necessary and/or ongoing training to energy vendors using eHEAT.
- 3. Make authorization through eHEAT, telephone, fax or electronic communication for:
 - Payments for electricity, heating fuels and delivery of fuel.
 - Continuation or reconnection of connected utilities.
 - Payments for fees including: service deposits, pressure tests, line bleeding, tank setting, tank rental, membership, if applicable.
 - Removal from load limiters.
 - Payments due and past due amounts for electricity and heating fuels.
- 4. Maintain a file of customer authorizations for exchange of private data between the Service Provider and the energy vendor.
- 5. Enter account number into eHEAT in the format supplied by the energy vendor.

III. The energy vendor will:

- 1. Ensure EAP eligible households are not treated adversely compared to other households. Oil and propane dealers are required to comply with the Discrimination Prohibition in Minn. Stat. §325E.027.
- 2. Supply account number format to the Service Provider.
- 3. Provide to the Service Provider a written price list for normal and customary services for home energy costs including but not limited to:
 - Leak seek and pressure tests
 - Bleeding lines
 - Tank setting
 - Service deposits
 - Reconnection fees
 - Membership fees
 - Minimum delivery requirements and costs
 - Emergency fuel and after hours delivery costs
- 4. When possible deliver remaining EAP benefit before September 30, 2014.
- 5. Provide at the request of the customer, the Service Provider or the State, information on applicant households' home energy costs, dwelling consumption data, delivery dates, bill payment history or arrearage history. This information will be provided in the format requested.
- 6. Provide dwelling consumption data within 5 business days of the request in eHEAT.
- 7. Respond promptly to consumption requests for crisis situations.
- 8. Register with EAP to receive payments.
- 9. Use the warrant or EFT date as the EAP payment date.
- 10. Apply all EAP payments to the households account within 5 business days of receipt of payment.
- 11. Apply EAP payments to the household's energy costs before applying other energy payments.

- 12. Accept all customer payments.
- 13. Use EAP funds to pay for home energy costs, including fuel and other routine and required services as designated by the Service Provider.

 Expenses such as service contracts, water, sewer, garbage, cable, internet, telephone, gasoline, machine parts, engine oil, etc. cannot be paid with EAP funds.
- 14. Continue service, reconnect or deliver fuel to households as negotiated by the Service Provider on behalf of the household.
- 15. When addressing household energy emergencies, when possible, accept eHEAT payment status of "Payable" for payment. When eHEAT is not available, accept early notification authorization by telephone, fax or electronic communication for delivery of fuel, continuation or reconnection of connected utilities, or service deposits if applicable, and removal from load limiters.
- 16. Accept a household application status in eHEAT of "approved" as income eligibility validation for the Energy Assistance Program.
- 17. Report dangerous heating or fuel delivery situations for EAP households to the Service Provider.
- 18. Process and refund to the State any refunds requested by the Service Provider within 10 business days.
- 19. Process and refund to the State all credits attributable to EAP payments made during FFY 2014 remaining on a customer's account within 10 business days after a client ceases to be a customer.
- 20. Upon customer request, return to the household any EAP funds remaining on the household's account after September 30, 2014.
- 21. Notify the Service Provider or DOC if there is reason to believe EAP funds have been misused as described in the EAP Policy Manual.
- 22. Allow the Service Provider or State access to fiscal records of EAP transactions for audit purposes for period of three (3) years after payment.
- 23. Complete and submit the EAP Leveraging Report to the State.
- 24. Use eHEAT when possible to administer EAP program business, including but not limited to:
 - Providing consumption
 - Maintaining energy vendor account numbers
 - Monitoring eligibility and payments
 - Recording refunds
- 25. Implement and maintain eHEAT database security policies by:
 - · Limiting access to authorized personnel only
 - Ensuring each user is assigned a unique user ID
 - Ensuring email addresses associated with each user ID are current
 - Disabling users immediately upon termination of their role in the service delivery of EAP
 - Disabling users who are on a temporary leave of absence, extended vacation, etc
- IV. Either party to this agreement may terminate it at any time, with or without cause, upon thirty days written notice to each other and the State.

 Upon termination, the energy vendor must provide an estimated final invoice for the energy vendor's services performed. Upon termination and submission of a final invoice, and upon acceptance of the final invoice by the state, the energy vendor will be entitled to payment for services satisfactorily performed.

City electrical crews will be able to handle some of the installation items thus reducing costs. It is recommended that the City Council authorize an capital improvement amount not to exceed \$40,000 for the purchase and installation of two early warning sirens.

DECLARING COST TO BE ASSESSED, AND ORDERING PREPARATION OF PROPOSED ASSESSMENT

WHEREAS, costs have been determined for Improvement Number 11-06, the improvement of Bluebell Avenue and Daffodil Avenue between the centerline of Unity Drive and the centerline of Jasmine Street by reconstruction or overlayment and the contract price for such improvement is \$123,968.00, and the expenses incurred in the making of such improvement amount to \$31,897.38 so that the total cost of the improvement will be \$155,865.38.

Enclosed, please find a real estate license agreement between the City and Minntac. Basically this agreement maintains open access to the Renewable Energy Park off of Mineral Avenue during the period in which the new County Road 102 will be under construction. Staff and the City Attorney have review this license and recommend it approval.

REAL ESTATE LICENSE AGREEMENT

This REAL ESTATE LICENSE AGREEMENT (this "License") is made as of this _____ day July 2013, by and between UNITED STATES STEEL CORPORATION, a Delaware corporation ("USS"), and the CITY OF MOUNTAIN IRON, a body public, corporate, and politic and a political subdivision under the laws of the State of Minnesota (the "City").

WITNESSETH:

WHEREAS, the Mt. Iron Economic Development Authority, a body public, corporate, and politic and a political subdivision under the laws of the State of Minnesota (the "EDA"), which is an affiliate of the City, owns certain real estate in the City of Mountain Iron, St. Louis County, Minnesota identified on "Exhibit A" attached hereto and incorporated herein by reference (the "Property");

WHEREAS, the EDA has previously constructed and currently maintains on the Property a gravel roadway (the "Old Roadway") to enable the City and the EDA and each of their employees, invitees, and licensees and members of the public (the "Benefited Parties") to access adjacent property owned by the EDA (the "Adjacent Property");

WHEREAS, USS has undertaken a project to relocate a portion of County State Aid Highway 102 from its current location to a new location (the portions of such highway in its new location, "New 102"), a portion of which will be on the Property;

WHEREAS, pursuant to a "Real Estate Purchase Agreement" (the "EDA Agreement"), the EDA has agreed to sell the Property to USS to enable USS to construct New 102 thereon;

WHEREAS, the activities to construct New 102 will render the Old Roadway unusable;

WHEREAS, upon completion of New 102, USS will dedicate New 102 to the County of St. Louis (the "Dedication"), at which time the Benefited Parties will be entitled to access the Adjacent Property via New 102;

WHEREAS, from the time at which USS' construction activities render the Old Roadway unusable until the Dedication of New 102, the Benefited Parties will require alternative access to the Adjacent Property; and

WHEREAS, the City desires to obtain from USS, and USS has agreed to grant to the City, a license to the portion of the Property to be reasonably designated by USS from time to time during the course of constructing New 102 (which may or may not be the future location of New 102), on which USS will construct a temporary roadway (the "Temporary Roadway") to enable the Benefited Parties to access the Adjacent Property.

NOW, THEREFORE, in consideration of all the covenants, terms, and conditions herein contained, and intending to be legally bound hereby, the parties hereto agree as follows:

1. Grant of License; Private License; Reservation of Rights; Exclusivity; Relocation.

- (A) The foregoing recitals are hereby incorporated into this License by reference as if fully set forth below.
- (B) Upon and subject to the terms hereof, USS hereby grants to the City a limited, revocable, non-exclusive right and license to access and use the Temporary Roadway during the term hereof for the following purpose, and the City agrees to use the Temporary Roadway only for this purpose and for no other purpose whatsoever: for the Benefited Parties' pedestrian and vehicular ingress, egress, and regress to and from the Adjacent Property from and to the nearest public roadway and for the City to maintain the Temporary Roadway as required hereunder.
- (C) The rights granted herein are limited to the Benefited Parties for the purposes stated herein and do not constitute a dedication of the Temporary Roadway.
- (D) USS hereby does, and the City hereby acknowledges and agrees that USS does, reserve any and all right, title, and interest in and to the Temporary Roadway and the remainder of the Property, including, the right to use the Temporary Roadway for any and all purposes whatsoever; and the right to mortgage, pledge, hypothecate, assign, lease, or otherwise transfer any or all of the Property or USS' right therein. Further, the City acknowledges and agrees that this License is subject to any and all highway, railroad, and other public or private rights or easements, existing in or across the Temporary Roadway or any part thereof, and to the rights of any person or other person who may have an interest in the Property, including any minerals therein.
- (E) The City hereby acknowledges and agrees that the rights hereunder are non-exclusive and that, among other rights reserved by USS, USS retains the right to grant one or more other parties the right to access and use the Temporary Roadway during the term hereof.
- (F) USS reserves the right, at any time and for any reason in USS' discretion, to relocate the location of the Temporary Roadway.
- 2. <u>Term.</u> The rights granted herein shall begin immediately following the closing of the EDA's sale of the Property to USS pursuant to the EDA Agreement and shall terminate on the effective date of the County of St. Louis' formal acceptance USS' Dedication of New 102.

3. Payments (Rent and Damages).

- (A) USS, the City, and the EDA acknowledge and agree that this License is being entered into pursuant to and as a condition to the EDA Agreement and other agreements, and that no additional consideration is being required from the City or the EDA to USS.
 - (B) The City shall pay USS for all damages to the Property or surrounding area.
- 4. <u>Termination: Default.</u> If the City fails to perform any of its covenants or obligations hereunder, and such failure continues for ten (10) days after USS gives the City written notice of said failure, then this License and all of the rights granted hereby shall forthwith cease and terminate as of such date without any further notice or other action on the part of USS.

5. Representations, Warranties, and Covenants.

- (A) The City covenants that its and its contractors' use of and activities on the Temporary Roadway shall at all times comply with all applicable present and future laws, ordinances, permits, rules, and regulations enacted by any federal, state, county, or municipal governmental agency having jurisdiction or control over said use and activities (including reclamation and/or pollution, environmental or otherwise) occurring upon the Temporary Roadway from the City's activities thereon. The City further agrees, if necessary, to obtain all permits for its activities hereunder at its sole expense and to comply with all such permits. The City shall provide USS with copies of said permit(s) and any and all associated documents, maps, and plans.
- (B) The City covenants and agrees that the City shall not grant, create, suffer, or permit any claim, encumbrance, easement, restriction, mechanic's or materialmen's liens, or other charge or exception to title to be placed on the Property or any other property of USS, whether by reason of any work, labor, services, materials, or equipment supplied or claimed to have been supplied to the City or any contractor or subcontractor of the City, or otherwise. If any such matter is filed against the Property or any other property of USS arising out of or relating to this License, then the City shall promptly, after notice of filing, either (i) cause the same to be discharged of record by deposit in court or by the issuance of a bond; or (ii) furnish USS with indemnification or other security against loss or damage arising from the lien in form and substance satisfactory to USS. If the City learns of any claim or action pertaining to any such liens with respect to the Property or any other property of USS, the City shall give prompt notice of the same to USS at the address identified herein.
- During the periods of time in which USS is actively constructing New 102 (i.e., **(C)** the construction season of each year), USS shall maintain the Temporary Roadway. During the periods of time in which USS is not actively constructing New 102, the City covenants that it shall keep the Temporary Roadway in good repair and in a safe, neat, and orderly condition and so maintain, use, and occupy the same as to protect life and property and so as not to create any public or private nuisance or damage or injury to any adjacent premises or to any persons or property thereon. Without limiting the generality of the foregoing, during the times in which the City is required to maintain the Temporary Roadway, the City shall maintain the Temporary Roadway during the winter months in the same manner in which the City maintains public roadways within the City's jurisdiction (including, without limitation, plowing snow from the Temporary Roadway and applying sand or other substances thereon to ensure vehicular traction thereon). In performing such maintenance, the City shall ensure that its employees or contractors do not unreasonably damage construction work performed by or for USS relating to the construction of New 102. USS and the City shall communicate with each other to coordinate the dates on which the maintenance obligations hereunder are to be transferred at the beginning and end of each construction season.
- (D) The City covenants that the City's and/or the City's contractors' occupancy or use of the Temporary Roadway shall not unreasonably interfere with USS', or any other licensee's, tenant's, invitee's, or other occupant's, use or occupancy of (and the City shall not, and shall not permit its contractors to, in any manner prevent USS' or any other licensee's, tenant's invitee's or other occupant's access to or use or occupancy of) the Temporary Roadway or the Property.

(E) USS retains the right to inspect the Temporary Roadway to ensure the City's compliance with its covenants hereunder.

6. <u>Disclaimers of Warranties; Limitations of Liability.</u>

- Disclaimers of Warranties. The City represents, warrants, acknowledges, and agrees that (i) it has examined and inspected the Property and that the City has determined that the Property is suitable for the City's uses contemplated hereunder, (ii) USS has not undertaken and will not be obligated to maintain the Temporary Roadway in any manner whatsoever, including, without limitation, maintaining the Temporary Roadway in a safe and habitable condition, (iii) USS' EXPRESS WARRANTIES HEREIN ARE ITS EXCLUSIVE WARRANTIES AND USS MAKES NO REPRESENTATIONS OR WARRANTIES REGARDING THE TEMPORARY ROADWAY, OR ANY **OTHER** WHATSOEVER, AND (iv) EXCEPT FOR USS' EXPRESS WARRANTIES HEREIN: (a) THE TEMPORARY ROADWAY ARE PROVIDED "AS-IS", "WHERE-IS", AND "WITH ALL FAULTS"; (b) TO THE FULLEST EXTENT PERMITTED BY LAW USS HEREBY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, WHETHER BY STATUTE, COMMON LAW, COURSE OF DEALING OR PERFORMANCE, TRADE USAGE, OR OTHERWISE, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
- (B) Limitation of Liabilities. (i) Notwithstanding any term or provision herein to the contrary, the City acknowledges and agrees that neither USS nor any party acting by, through, or for USS or on USS' behalf shall have any personal liability whatsoever. (ii) IN NO EVENT SHALL USS BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL, PUNITIVE, OR OTHER INDIRECT DAMAGES, HOWEVER CAUSED, INCLUDING BUSINESS INTERRUPTION OR LOST PROFITS.

7. <u>Insurance</u>.

- (A) During the entire term hereof, the City will obtain and maintain in full force and effect, and will cause its contractors to maintain in full force and effect, insurance coverage in accordance with the terms and provisions outlined in Attachment "I" attached hereto and incorporated herein. The City further agrees that before it or any of its contractors visits or occupies the Temporary Roadway that it shall provide USS with proof of the aforementioned insurance coverage in a form suitable to USS.
- (B) The obligations set forth in this Section and in Attachment "I" shall survive the expiration or termination of this License as to any matters that occurred during or resulted from the term of this License.

8. <u>Indemnification; Defense.</u>

(A) The City, for itself and its successors and assigns, agrees to and hereby does indemnify and hold harmless USS, its parents, subsidiaries, affiliates, and divisions, and each of their shareholders, members, and partners, and each of their officers, directors, employees, agents, representatives, and contractors, and each of their heirs, personal representatives, successors, and assigns (the "Indemnified Parties") from and against any and all claims,

actions, losses, liabilities, obligations, costs, expenses, fines, fees, verdicts, judgments, or any other damages, of any nature whatsoever, whether arising from contract, tort, or otherwise, including, without limitation, reasonable attorney's fees, defense costs, investigation expenses, discovery costs, court costs, and all other expenses, arising from or relating to: (i) the City's performance or nonperformance of any term or condition of this License; (ii) bodily injury, illness, disease, death, property damage, or loss of use, maintenance, cure, profit, or wages occurring on or caused by occurrences on the Temporary Roadway; (iii) the City's violation of any ordinance, permit, order, law, regulation, statute, legislation, judgment, or decree; and/or (iv) any use by the City or the Benefited of the Temporary Roadway or any common area or any other property of USS, including the City's or the Benefited Parties' presence, occupancy or use of the Temporary Roadway prior to the Commencement Date and after the termination of this License, and in any and all events, including, without limitation, (a) any acts or omissions of the City's or the EDA's agents, employees, managers, visitors, contractors, subcontractors, lessees, sublessees, invitees, licensees, customers, concessionaires or assignees and (b) any and all acts or omissions, including, without limitation, the actual or alleged negligence of one or more of the Indemnified Parties, whether or not occurring on the Temporary Roadway and whether or not such acts or omissions cause or result in bodily injury, illness, disease, death, property damage, or loss of use, maintenance, cure, profit, or wages of employee(s) of USS or the City (all of the foregoing, the "Indemnified Matters"). The City agrees that the indemnity provided by this paragraph is unlimited and the City waives any and all statutory tort limitations provided for in Minnesota Statutes as such limits pertain to USS. The City retains the statutory tort limitations as such limits apply to the City's liability to other third parties.

- (B) The City agrees to defend each of the Indemnified Parties, at the City's sole cost and expense, in any litigation, action, arbitration, mediation, or other legal or administrative proceeding against one or more of the Indemnified Parties arising from or relating to any of the Indemnified Matters; provided that the Indemnified Party shall have the right to approve or disapprove of (i) counsel chosen by the City to represent the Indemnified Party in any such matter, and in the event counsel chosen by the City is unacceptable to the Indemnified Party, the Indemnified Party may engage its own counsel, at the City's sole cost and expense, to represent the Indemnified Party in such matter, (ii) defenses, counterclaims, or cross claims to be raised or made by or on behalf of the Indemnified Party, and (iii) whether or not to settle any such matter.
 - (C) The terms of this Section shall survive the expiration or termination hereof.

9. Environmental Laws; Hazardous Substances.

(A) <u>Definitions</u>. - (B) <u>Covenant</u>. The City covenants that, except in compliance with Environmental Laws, (i) no inflammable, explosive, or dangerous fluids or substances shall be used or kept on or about the Temporary Roadway or any other property of USS, (ii) neither the City nor any of the Benefited Parties shall, without USS' prior written consent, bring, introduce, install, store, maintain, use, spill, remove, release, or dispose of any Hazardous Material on or about the Temporary Roadway or any other property of USS, (iii) the City and the Benefited Parties shall, and its use of the Temporary Roadway shall, comply with all Environmental Laws, and (iv) the City will immediately notify USS of (a) any violation of any Environmental Law, (b) receipt of any notice or warning from, and/or any visit by, any environmental governmental agency for any reason whatsoever.
- (C) <u>Survival</u>. The terms of this Section shall survive the expiration or earlier termination hereof.

10. Miscellaneous.

- (A) Entire Agreement; Binding Effect. This License, including any terms and conditions incorporated herein or attached hereto, constitutes the entire agreement between the parties, and there are no representations, oral or written, that have not been incorporated herein. This License shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto. No representation, inducement, promise, understanding, condition, or warranty not set forth herein has been made or relied upon by either party.
- (B) Amendment. This License may be amended, renewed, extended, or canceled only by a written instrument executed on behalf of each of the parties hereto by an authorized representative of each party, and neither party shall, at any time or in any way, assert or contend that any amendment, extension or cancellation of this License (or any part or parts, including this Section) has been made other than by a written instrument so executed.
- (C) Assignment. The City may not transfer or assign its rights and obligations under this License, in whole or in part, without the prior written consent of USS. Additionally, USS and the City do not intend to, nor do they, create any rights in any third party or person not a signatory to this License.
- (D) Notice. Any notice that may at any time be required to be given hereunder shall be deemed to have been properly given if personally hand delivered to the other party, or if sent by United States first class registered or certified mail, postage prepaid, or by facsimile transmission, addressed as follows:

Each party, for itself and its heirs, representatives, successors, and assigns, hereby irrevocably consents to the exclusive jurisdiction of the federal and state courts sitting in or for the county in which the Property are located for the resolution of any conflicts arising hereunder, and each agrees that such courts are the proper and convenient venue and waive any right to object to such venue as being inconvenient or otherwise.
- **(F)** Counterpart. This License may be signed in one or more counterparts, and by facsimile transmission, all of which shall be treated as one and the same original agreement. Each party shall provide an executed copy to the other.
- (G) Severability. If any provision of this License is found to be invalid or otherwise unenforceable in any court of competent jurisdiction, the allegedly invalid or unenforceable provision shall be deemed valid and enforceable to the maximum extent permitted by law and shall be deemed to be amended to the minimum extent necessary to make it valid and enforceable in such jurisdiction, and the alleged invalidity and/or unenforceability in such jurisdiction shall not affect the validity or enforceability of any other provision hereof in such jurisdiction or the validity or enforceability of the allegedly invalid and/or unenforceable provision, or of any other provision hereof, in any other jurisdiction.

ATTACHMENT "I" INSURANCE REQUIREMENTS

Contractor shall procure and maintain, at its own expense, and shall require its Subcontractor(s), if any, to procure and maintain for the duration hereunder the insurance coverage meeting or exceeding the requirements set forth below:

- 1. <u>Minimum Scope of Insurance</u> -- Coverage shall be at least as broad as the following:
- A. <u>Commercial General Liability Insurance</u>: Shall be written on ISO occurrence form CG 00 01 (or a substitute form providing equivalent coverage) and shall cover liability arising from premises, operations, independent contractors, products-completed operations, personal injury and liability assumed under an insured contract (including the tort liability of another assumed in a business contract). If a 1973 edition ISO form must be used by the insurer, the broad form comprehensive general liability (BFCGL) endorsement shall be included. Additionally, the policy shall not contain a sunset provision, commutation clause or any other provision which would prohibit the reporting of a claim and the subsequent defense and indemnity that would normally be provided by the policy. The policy of insurance shall contain or be endorsed to include the following:
 - (i) Premises/Operations;
 - (ii) Products/Completed Operations;
 - (iii) Contractual:
 - (iv) Independent Contractors:
 - (v) Broad Form Property Damage:
 - (vi) Personal and Advertising Injury;
 - (vii) Separation of Insureds (Severability of Interest);
 - (viii) The policy shall be endorsed using ISO form CG 20 10 11 85 (or a substitute form providing equivalent coverage) so as to include United States Steel Corporation (hereinafter "USS") and its affiliates, including all units, divisions and subsidiaries as Additional Insureds on a primary and non-contributory basis. The coverage shall contain no special limitations on the scope of protection afforded to said Additional Insured.
 - (ix) Waiver of subrogation shall be provided to the benefit of all Additional Insureds, as aforesaid.
 - (x) No XCU (explosion, collapse, underground) exclusion.

- (xi) For any claims related herein, the Contractor's and its Subcontractor's insurance shall be primary and non-contributory respecting the aforesaid Additional Insureds. Any insurance or self-insurance maintained by USS shall be in excess of the Contractor's and its Subcontractor's insurance and shall not contribute with it.
- (xii) The policy shall not contain any provision, definition, or endorsement which would serve to eliminate third-party action over claims.
- (xiii) The policy shall not be endorsed to include ISO endorsement form CG 24 26 or any similar provision.
- (xiv) Self-funded or other non-risk transfer insurance mechanisms are not normally acceptable to USS. If the Contractor and/or Subcontractor has such a program, full disclosure must be made to USS prior to any consideration being given.

SPECIAL NOTE: If watercraft are used in connection with operations, evidence of watercraft liability coverage is required, subject to USS's approval.

- B. <u>Automobile Liability Insurance</u>: As specified by ISO form number CA 0001, Symbol I (any auto), with an MCS 90 endorsement and a CA 99 48 endorsement attached if hazardous materials or waste are to be transported. This policy shall be endorsed to include USS and its affiliates, including all units, divisions and subsidiaries as Additional Insureds, and to include waiver of subrogation to the benefit of all Additional Insureds, as aforesaid.
- C. <u>Workers' Compensation Insurance</u>: As required by the State or Commonwealth in which work is being done, and in accordance with any applicable Federal laws, including Employer's Liability Insurance and/or Stop Gap Liability coverage as per below limits. Where not otherwise prohibited by law, this policy shall be endorsed to include waiver of subrogation to the benefit of USS and its affiliates, including all units, divisions and subsidiaries.
- **D.** <u>Employer's Liability and/or Stop Gap Liability Coverage</u>: Coverages per accident, disease-policy limit, and disease each employee.

F. Environmental Impairment Insurance (If made applicable by USS):

Covering damage to the environment, both sudden and non-sudden, caused by the emission, disposal, release, seepage, or escape of smoke, vapors, soot, fumes, acids, alkalis, toxic chemicals, liquid or gases, waste materials or other irritants, contaminants or pollutants, into or upon land, the atmosphere or any water course or body of water; or the generation of odor, noises, vibrations, light, electricity, radiation, changes in temperature, or any other sensory phenomena. Such insurance shall contain or be endorsed to include:

- Property damage, including loss of use, injury to or destruction of property;
- (ii) Cleanup costs which shall include operations designed to <u>analyze</u>, <u>monitor</u>, remove, remedy, neutralize, or clean up any released or escaped substance which has caused environmental impairment or could cause environmental impairment if not removed, neutralized or cleaned up.
- (iii) Personal injury, which shall include bodily injury, sickness, disease, mental anguish, shock or disability sustained by any person, including death resulting therefrom.
- (iv) USS and its affiliates, including all units, divisions and subsidiaries as Additional Insureds, on a primary and non-contributory basis.
- (v) Waiver of Subrogation in favor of USS and its affiliates, including all units, divisions and subsidiaries.

If the Environmental Impairment Insurance is on a claims-made form, Contractor shall maintain continuous coverage or exercise an extended discovery period for a period of no less than five (5) years from the time that the work hereunder has been completed.

- 2. <u>Minimum Limits of Insurance</u> Contractor and its Subcontractor(s) shall maintain limits no less than:
- A. <u>Commercial General Liability</u>: Including Umbrella Liability Insurance, if necessary, limits shall be not less than \$5,000,000 each occurrence for personal injury and property damage; \$5,000,000 each occurrence and aggregate for products and completed operations; \$5,000,000 general aggregate. The limits and coverage requirements may be revised at the option of USS.
- B. <u>Automobile Liability Insurance</u>: Including Umbrella Liability Insurance, if necessary, limits shall be not less than \$2,000,000 per accident for bodily injury and property damage, \$5,000,000 if hazardous materials or substances are to be transported.
- C. <u>Workers' Compensation</u>: As required by the State or Commonwealth in which the work will be performed, and as required by any applicable Federal laws.
- D. Employer's Liability and/or Stop Gap Liability Coverage and/or
 Employer's Liability including Maritime Employer's Liability: \$1,000,000 per accident, \$1,000,000 disease-policy limit, and \$1,000,000 disease each employee. (May include Umbrella coverage.)
- E. <u>Errors and Omissions Professional Liability Insurance</u>: (**If applicable**) \$2,000,000 per loss: \$4,000,000 annual aggregate limit.
- F. <u>Environmental Impairment Insurance</u>: (If applicable) \$5,000,000 combined single limit per loss. The limits and coverage requirements may be revised at the option of USS.
- 3. <u>Deductibles and Self-Insured Retentions</u> -- All insurance coverage carried by Contractor and its Subcontractor(s) shall extend to and protect USS, its subsidiaries and/or affiliates to the full amount of such coverage, and all deductibles and/or self-insured retentions (if any), including those relating to defense costs, are the sole responsibility of Contractor and its Subcontractor(s).
- 4. <u>Rating of Insurer</u> The Contractor and its Subcontractor(s) will only use insurance companies acceptable to USS and authorized to do business in the state or area in which the work hereunder is to be performed. Insurers must have a minimum rating of A-, Class VII, as evaluated by the most current A.M. Best rating guide. If the insurer has a rating less than an A-, Class VII, the Contractor must receive specific written approval from USS prior to proceeding.

5. Other Insurance Provisions

- A. Each insurance policy required by this clause shall be endorsed to state that coverage shall not be suspended, voided, cancelled, reduced in coverage or in limits, or certificate holder deleted as additional insured except after thirty (30) days prior written notice by certified mail, return receipt requested, has been given to USS.
- **B.** These insurance provisions are intended to be a separate and distinct obligation on the part of the Contractor. Therefore, these provisions shall be enforceable and Contractor and its Subcontractor(s) shall be bound thereby regardless of whether or not indemnity provisions are determined to be enforceable in the jurisdiction in which the work covered hereunder is performed.

- C. The above-described insurance coverage to be provided by Contractor and its Subcontractor(s) hereunder will extend coverage to all work or services performed hereunder.
- **D.** The obligation of the Contractor and its Subcontractor(s) to provide the insurance herein above specified shall not limit in any way the liability or obligations assumed by the Contractor and its Subcontractor(s) hereunder.
- E. In the event Contractor and its Subcontractor(s), or its insurance carrier defaults on any obligations hereunder, Contractor and its Subcontractor(s) agree that they will be liable for all reasonable expenses and attorneys' fees incurred by USS to enforce the provisions hereunder.

6. Evidence of Coverage

- A. Contractor shall furnish to USS copies of the endorsements effecting the coverage required by this specification. Additionally, *prior to the commencement of any work or services on USS's Premises*, Contractor shall furnish to USS Certificates of Insurance evidencing full compliance with the requirements herein. The Certificates of Insurance must show that the required insurance is in force, the amount of the carrier's liability thereunder, and must further provide that USS will be given thirty (30) days advance written notice of any cancellation or reduction in coverage or in limits, or deletion of the certificate holder herein as an Additional Insured under the policies. Contractor shall also carry such additional insurance as USS may specify in connection with the contractor's performance of its obligations under this agreement.
- **B.** All Certificates of Insurance shall be in form and content acceptable to USS and shall be submitted to USS in a timely manner so as to confirm Contractor's full compliance with the insurance requirements stated hereunder.
- C. Any failure on the part of USS to pursue or obtain the Certificates of Insurance required hereunder from Contractor and/or the failure of USS to point out any non-compliance of such Certificates of Insurance shall not constitute a waiver of any of the insurance requirements hereunder, nor relieve Contractor of any of its obligations or liabilities hereunder. Moreover, acceptance by USS of insurance submitted by the Contractor does not relieve or decrease in any manner the liability of the Contractor for performance hereunder. The Contractor is responsible for any losses, claims, and/or costs of any kind which their insurance does not cover.
- D. In addition to its other remedies, USS may, at its sole option and without liability to Contractor, suspend the work and/or exclude Contractor from USS's premises until Contractor furnishes satisfactory evidence of its full compliance with the provisions hereunder.
- 7. <u>Subcontractors</u> -- Prior to the commencement of any work or services on USS's Premises, Contractor shall be responsible to obtain separate Certificates of Insurance from each Subcontractor. All coverages for Subcontractors shall be subject to all of the requirements stated herein.
