MINUTES MOUNTAIN IRON CITY COUNCIL SEPTEMBER 17, 2012

Mayor Skalko called the City Council meeting to order at 6:31 p.m. with the following members present: Joe Prebeg, Jr., Susan Tuomela, Ed Roskoski, and Mayor Gary Skalko. Absent member included: Tony Zupancich. Also present were: Craig J. Wainio, City Administrator; Jill M. Clark, Municipal Services Secretary; Rod Flannigan, City Engineer; Michael Downs, Interim Public Works Director; John Backman, Sergeant; and Brian Lindsay, City Attorney.

It was moved by Skalko and seconded by Tuomela that the consent agenda be approved as follows:

- 1. Approve the minutes of the September 4, 2012, regular meeting as submitted.
- 2. That the communications be accepted and placed on file and those requiring further action by the City Council be acted upon during their proper sequence on the agenda.
- 3. To acknowledge the receipts for the period September 1-15, 2012 totaling \$133,184.58, (a list is attached and made a part of these minutes).
- 4. To authorize the payments of the bills and payroll for the period September 1-15, 2012, totaling \$535,547.01, (a list is attached and made a part of these minutes).

The motion carried on the following roll call vote: Prebeg, yes; Tuomela, yes; Roskoski, no; Skalko, yes; and Zupancich, absent.

At 6:33 p.m., Councilor Roskoski vacated his chair and approached the podium for the public forum. Councilor Roskoski made a presentation of a historic picture of Steam Locomotive 806 that is currently located in Locomotive Park in Downtown Mountain Iron to the City. Councilor Roskoski stated that the picture was taken October 5, 1943, and found in the University of Minnesota Archives by Marvin Saari. He also thanked Barb Tucker from Andrews Camera for retouching the photo, enlarging it, and framing it. The Mayor thanked those involved with the donation of the picture.

The City Administrator reported on the following:

➤ AFSCME Local Union #453. He advised the Council that the Negotiating Committee met with AFSCME Local Union #453 and had come to a tentative agreement. He advised the Council that the union did meet and approved the tentative contract. The tentative agreement would be presented to the City Council at the next regular meeting.

Councilor Roskoski questioned the Sergeant and the City Administrator regarding a directional issue going east on Highway 169. The Mayor asked the City Administrator and the Interim Director of Public Works to contact the Minnesota Department of Transportation to inquire about adding some directional signage.

The Council reviewed the Sheriff's Department monthly statistical reports for the months of July and August, 2012.

It was moved by Prebeg and seconded by Tuomela to authorize payment request number one for the Locomotive Park Improvements-Phase II Project to Jola and Sopp Excavating Incorporated in the amount of \$29,782.50. The motion carried on the following roll call vote: Tuomela, yes; Roskoski, no; Prebeg, yes, Skalko, yes; and Zupancich, absent.

It was moved by Prebeg and seconded by Tuomela to accept the recommendation of the Planning and Zoning Commission and authorize the Conditional Use Permit for Robert Niemi to construct a 1,040 square foot building on his property located at 8788 Mud Lake Road, Mountain Iron, parcel code 175-0056-00080. After further discussion, Councilor Prebeg withdrew his motion and Councilor Tuomela withdrew her support.

It was moved by Prebeg and seconded by Tuomela to refer the Robert Niemi Conditional Use Permit application back to the Planning and Zoning Commission for reconsideration due to the need for a variance for the height of the building. The motion carried with Zupancich absent.

It was moved by Prebeg and seconded by Roskoski to accept the recommendation of the Personnel Committee and approve the Memo of Understanding which provides for a stipend for pager call, Article III, Section G, (a copy is attached and made a part of these minutes). The motion carried unanimously on a roll call vote with Zupancich absent.

Councilor Roskoski inquired about City Staff contacting Saint Louis County regarding adding a right turn lane at the intersection of County Road 7 and Unity Drive. The City Engineer informed the Council that he was informed that there was not sufficient right-of-way to make the turning lane.

The following Liaison Reports were given:

➤ Library Board. Councilor Tuomela informed the Council that the Library Board had a meeting recently and they discussed security of the library, updating the library policies, strategic plan discussion, and the Library Director's employment agreement.

- ➤ Community Conversations. Councilor Tuomela updated the Council regarding the meetings. She said that there were 730 participants and 12 cities involved covering numerous topics. She said that copies of the information were available upon request.
- Mesabi Daily News. Councilor Tuomela addressed a recent onion in the newspaper. She said that there was information regarding her platform when she ran for election, she asked where the onion writer was when she had an open forum at the Mountain Iron Library for eight Saturdays. She suggested that the onion writer apply for open positions in the City.

It was moved by Skalko and seconded by Prebeg to authorize a contribution of \$500 to the Virginia Regional Medical Center Foundation for the Dance for a Cure Event on October 5, 2012 in Virginia, with the funds being expended from Charitable Gambling. The motion carried on a roll call vote with Zupancich absent.

It was moved by Prebeg and seconded by Tuomela to allow the Special Events Coordinator to expend \$500 from the Charitable Gambling Fund to purchase new games for the Halloween Carnival. The motion carried on a roll call vote with Zupancich absent.

It was moved by Roskoski and seconded by Prebeg to contribute \$100 to the Rural Housing Coalition with the funds being expended from the Charitable Gambling Fund. The motion carried on a roll call vote with Zupancich absent.

At 7:21 p.m., it was moved by Skalko and seconded by Tuomela that the meeting be adjourned. The motion carried with Zupancich absent.

AMENDMENT TO SERVICES AGREEMENT

Safety Management Program

Contract Date: August 27, 2012 Contract Number: 20-2013

The services agreement entered into between Minnesota Municipal Utilities Association (MMUA) and Mountain Iron Public Utilities (Mountain Iron), dated August 30, 2011, contract number 20-2012, is amended as follows:

PART II, Section 1.

1. DURATION: This Agreement shall remain in force from October 1, 2012 until September 30, 2013 (the "expiration date").

PART III, Section 1.

1. COMPENSATION: For the services covered by this Agreement, Mountain Iron shall pay MMUA an annual fee of nine thousand three hundred dollars and 00 cents (\$ 9,300.00) for the 2012-13 annual period. Such compensation shall be due and payable according to the selected payment terms below.

Payment terms for the fee agreed to above shall be based on one of the following options (select one):

- Annual Payment (\$ 9,300.00)
- Quarterly Payments (\$ 2,325.00 each)

For any term of less than twelve full calendar months, the fee shall be a portion of the annual fee, pro-rated based on the number of calendar months or partial calendar months in which the services were provided as a percentage of twelve (12).

The parties hereby accept the terms of the Agreement as modified.


On behalf of Iron Range Youth in Action, *thank you so much* for your recent donation in helping us continue to rebuild homes for victims of Hurricane Katrina.

41 Iron Range Youth in Action members, from ten Iron Range schools, and 11 chaperones traveled to Lafayette, Louisiana, the week of July 28 – August 4, 2012, to help in the re-building effort caused, in part, by the effects of Hurricane Katrina 7 years ago.

Our group split into three different teams and worked on three different homes, all in various stages of completion: House #1 – Tiled and grouted kitchen, living room, hallway, and 2 bathrooms, installed snap-together laminate flooring in 3 bedrooms, caulked, painted siding, primed and painted trim; House #2 – Finished sheeting roof and gable ends, installed interior walls and bracing, tyveked exterior, installed doors and windows, caulked, sided and trimmed home, painted siding, primed trim; House #3 – Started with a

cement slab, erected walls, put up trusses, sheeted walls and roof. Our day started at 7:00 a.m. working until 4:00 p.m. with the heat index at 108 degrees every day. The Habitat staff took notes on how our group worked so well together. They were so impressed by our work and the amount we got accomplished. We put them weeks ahead of the completion dates on these homes. We also worked with owners of two of the homes.

Funding for this trip was raised through donations and many fundraising events held this past year in many communities across the Iron Range. They included Burger Bashes, Gulf Coast Raffle, the 7th Annual Quad-Cities Variety Show and Silent Auction, holiday gift wrapping at the Thunderbird Mall, cookie dough & pizza sales, Herberger's coupon book sales, business donations, etc.



This trip was a life-changing and moving experience for all involved. We were all touched by the spirit and generosity of the homeowners and Habitat staff, as well as others who blessed us for taking the time to come and help out our southern neighbors. So again, thank you for your support and commitment to the youth of North St. Louis County in making this trip possible. It is hard to put into words what was really accomplished. Teamwork – Compassion – Pride – Inspiration – instilling in our youth that they can really make a difference and hope they continue to do so throughout their lives.

Dear Craig Wainio:

Minnesota Power proposes to construct an approximate 3-mile-long, 115 kilovolt (kV) high voltage transmission line in St. Louis County near the City of Eveleth, Minnesota. This project is referred to as the 39 Line Project (Project). The Project is needed to provide a new source of power to the surrounding area as a result of United Taconite's plans to expand its mining operation west of the City of Eveleth.

The purpose of this letter is to provide you notice of Minnesota Power's plan to obtain a Route Permit from the Minnesota Public Utilities Commission (MPUC) for the proposed Project. Minnesota Power plans to submit a Route Permit Application (RPA) to the MPUC within the next few months. We request your questions or comments regarding the Project prior to filing the RPA with the MPUC.

Description of the Project

A Project map is attached for your reference (see **Figure 1**). The Project location is further described in the following table.

The Project generally consists of constructing a new 115 kV transmission line from Minnesota Power's existing 39 Line along the western edge of the City of Eveleth, around United Taconite's existing north pit, west through the City of Leonidas, and connects with Minnesota Power's existing 37 Line as shown on **Figure 1**. The proposed 115 kV transmission line will extend approximately 3 miles.

Minnesota Power would also, at the request of United Taconite, remove its existing 39 Line that runs through United Taconite's north pit; also shown on **Figure 1**. Please note that Minnesota Power is in the process of evaluating routing information and collecting comments and input, and that the proposed route location shown on Figure 1 is preliminary and subject to change through this process.

The Project area is located in a primarily commercial/industrial use area, and is anticipated to be adjacent to existing road corridors for the majority of its length. Some residential development is also located within the Project area.

Depending upon the final selected route, the Project may cross over roads, small waterbodies, and wetlands. Much of the Project will be located on land owned by United Taconite who has assisted with the development of the preliminary route corridor. For new construction of the 39 Line, Minnesota Power plans to propose a 500-foot-wide route corridor with the MPUC. The proposed transmission line will occupy a 100-foot-wide right-of-way located within the 500-foot-wide route corridor.

Permitting Requirements

The proposed new 115 kV transmission line meets the definition of a High Voltage Transmission Line (HVTL) under Minn. Rules Chapter 7850.1000, subp. 9. Minnesota Power will apply for a Route Permit required for the Project which, qualifies for the Alternative Permitting Process under Minn. Stat. § 216E.04, subd. 2(3) and pursuant to Minn. Rules Chapter 7850.2800 to 7850.3900 (see Minn. Rules Chapter 7850.2800, subp. 1(C)), which Minnesota Power may elect to use.

The Route Permit proceedings will determine where the proposed facilities will be located. As part of the permitting process, the MPUC considers input from the applicant utility, interested stakeholders, local government units, state and federal agencies, and landowners who may be affected by the Project. Additional environmental review will occur during the routing process. The routing process will consider environmental, land use, and other potential routing impacts, and provide the opportunity for the public to comment.

An informational open house regarding this project is being held at the **Leonidas Community Center located at 201 1**st **Street, Eveleth, MN 55734 on Thursday, October 11, 2012 from 6:00PM to7:30PM**. 
